Central New York Leadership Development Program – Now Accepting Applications

Applications are now being accepted for those teachers interested in applying for admittance into the Central New York Leadership Development Program (CNYLDP) for the 2015-16 school year. This program is a joint leadership venture between local school districts through OCM BOCES and Le Moyne College. Candidates selected for the program will be expected to complete three semesters of course work (Fall, Spring, and Summer). Each semester will involve a 3-credit graduate course affiliated with Le Moyne College. Courses will consist of on-site practically based projects, large group seminars and frequent meetings with an assigned mentor. Successful candidates who complete the 3 semesters, 3-credits each semester, and choose to pursue their Certificate of Advanced Studies (CAS) through Le Moyne College, will be eligible to apply these credits toward the completion of their CAS degree.
