b.The district's failure to adhere to the standards and methodologies required for the Annual Professional Performance Review, pursuant to *Education Law* §3012-d and applicable rules and regulations;

c.The district's failure to comply with either the applicable regulations of the Commissioner of Education, or locally negotiated procedures; d.The district's failure to issue and/or implement the terms of the Teacher Improvement Plan, where applicable, as required under *Education Law* §3012-d.

In order to be timely, the notification of the APPR appeal shall be filed, in writing, within fifteen (15) school days after the teacher has received the APPR. Notification of the appeal shall be provided to the superintendent of schools or his designee. If a teacher is challenging the issuance or implementation of a teacher improvement plan, the appeal must be submitted in writing within fifteen (15) school days of issuance or of the time when the teacher knew or should have known of an alleged implementation breach of such plan.

When filing an appeal, the teacher must submit a detailed written description of the specific grounds for the appeal as well as the performance review and/or improvement plan being challenged. Along with the appeal, all supporting documentation must be submitted, or specifically noted if pending. Any grounds for appeal or any supporting documentation/information not submitted or noted at the time the appeal is filed shall not be considered. Within five school days of receipt of an appeal, the supervising administrator must submit a detailed written response. The response must include any and all additional documents or written materials that are specific to the points of disagreement and/or are relevant to the resolution of the appeal. Material not submitted at the time the response is filed shall not be considered in the deliberations related to the resolution of the appeal. Decisions on Appeal:

Step 1 - Meeting with the supervising administrator will occur within 5 days of receipt of final evaluation. The bargaining unit member shall upon request be entitled to an Association representative being present. This meeting shall be an informal meeting wherein the authoring administrator and the employee are able to discuss the evaluation and the areas of dispute. If the bargaining unit member is not satisfied with the outcome, he/she may proceed to the second step. The second step shall be initiated by the unit member and/or the Association notifying the Superintendent in writing, within 5 days of the conclusion of the conference.

Step 2 - Within five school days of receipt of the level 1 response, if a teacher and/or Association is not satisfied with the response the teacher and/or Association must submit the appeal to the Superintendent of Schools or the Superintendent's designee. The Superintendent or designee will be provided with all documentation submitted in step one of the appeal and the responses from the evaluator. In the case where the Superintendent and the evaluator is the same person, The Superintendent will designate at least two administrators to act as proxy.

Within five school days of receipt of the teacher's appeal, the Superintendent or designee will conduct a hearing at which the teacher (and representative at the option of the teacher) and the evaluator (and representative at the option of the evaluator) will be allowed to present oral arguments in support of the appeal and the response, respectively.

Within five school days of the Superintendent hearing, the Superintendent or designee will issue a written determination to the teacher, the Teacher's Association President, and the evaluator, this determination will be final and binding for those appealing their developing rating.

Within five school days of receipt of the Superintendent's response, if the teacher or the Association are not satisfied with such response the appeal may be submitted to Arbitration if and only if the overall rating is ineffective. Appeals shall be decided in final and binding arbitration by the arbitrator. The arbitrator has 15 days from receipt to make the determination. The arbitrator shall be mutually agreed upon between the Association and the District. If the District and the Association cannot agree on an arbitrator, the American Arbitration Association will be used. The demand for arbitration shall be filed within five school days after notification of the step three appeal is delivered by the Superintendent or designee. The cost of the arbitration shall be borne equally by the District and the Association.

If the Association does not agree to take the appeal forward to arbitration, the teacher may do so at his/her own expense using the procedure set forth above. In that case, if any rating is positively changed, the District shall pay the entire cost of the arbitration. If the rating is unchanged, the appealing teacher shall pay the entire cost of the arbitration.

The decision shall set forth reasons and factual basis for each determination on each of the specific issues raised in the appeal. The arbitrator shall have the authority to rescind, modify, or affirm the rating.

All evaluators, independent evaluators, and lead evaluators have participated in (and will continue to participate in) the teacher evaluator training series that is offered through the St. Lawrence-Lewis BOCES. Training will address the nine elements required by Regents Rules section 30-3.10. The minimum duration of initial training will be two days.

Ongoing training opportunities through the St. Lawrence-Lewis BOCES will enable all evaluators to refresh their learning, and all evaluators will receive the full training series. Each year, all certified evaluators will attend SLL BOCES sponsored sessions in order to become re-certified. These sessions will focus upon continuing calibration of all evaluators, ensuring inter-rater agreement and inter-rater reliability. All evaluators will participate in these early yearly sessions to become recalibrated, and SLL BOCES will assure recertification.

All District teacher evaluators will also participated in two full days of Marzano framework instruction, focused on inter-rater agreement and interrater reliability. These sessions are led by trainers from Learning Sciences International who are deeply familiar with hte Marzano framework. All will also participate in training from NorthEast Regional Information Center (NERIC) staff on the use of iObservation electronic platform (within which the district) will house its Marzano framework rubrics, instruments, and evidence.

Based upon their participation in these activities, all District teacher evaluators will be certified by the Superintendent and Board of Education as lead evaluators and evaluators.

c.The district's failure to comply with either the applicable regulations of the Commissioner of Education, or locally negotiated procedures; d.The district's failure to issue and/or implement the terms of the Principal Improvement Plan, where applicable, as required under *Education Law* §3012-d.

In order to be timely, the notification of the APPR appeal shall be filed, in writing, within fifteen (15) school days after the principal has received the APPR. Notification of the appeal shall be provided to the superintendent of schools or his designee. If a principal is challenging the issuance or implementation of a principal improvement plan, the appeal must be submitted in writing within fifteen (15) school days of issuance or of the time when the principal knew or should have known of an alleged implementation breach of such plan.

When filing an appeal, the principal must submit a detailed written description of the specific grounds for the appeal as well as the performance review and/or improvement plan being challenged. Along with the appeal, all supporting documentation must be submitted, or specifically noted if pending. Any grounds for appeal or any supporting documentation/information not submitted or noted at the time the appeal is filed shall not be considered.

Within five school days of receipt of an appeal, the superintendent must submit a detailed written response. The response must include any and all additional documents or written materials that are specific to the points of disagreement and/or are relevant to the resolution of the appeal. Material not submitted at the time the response is filed shall not be considered in the deliberations related to the resolution of the appeal.

Appeals are limited to ineffective composite ratings for first year principals, to ineffective or developing ratings for all other principals, and to those improvement plans that are generated as the result of an ineffective or developing composite rating. All grounds for appeals must be raised with specificity within a single appeal and the burden of demonstrating a right to the relief requested is with the principal.

There are three levels of appeal which must be processed within a maximum of 70 calendar days, process will be timely and expiditous in accordance with education law 3012-d.

- 1. Superintendent Lead Evaluator (filing within 15 calendar days and response within 15 calendar days of the filing), if principal doesn't agree with the response from the evaluator, the principal will move to step 2.
- 2. Bi-partisan panel (filing within 10 calendar days, review and recommendation will be given within 10 calendar days and be given to the principal and the superintendent within 10 calendar days), if principal doesn't agree with the decisions will move to step 3.
- 3. District superintendent of St. Lawrence-Lewis BOCES for final determination (filing within 10 calendar days of panel's recommendation and binding determination by the district superintendent within 10 calendar days of submission to the district Superintendent of SLL BOCES. This appeals procedure constitutes the exclusive means for initiating, reviewing, and resolving these appeals.

All Evaluators, independent evaluators and lead evaluators will participate in the St. Lawrence-Lewis BOCES training series on Principal Evaluation. As new evaluators are hired, they will participate in the SLL BOCES training academy. The content of the training will focus upon the nine elements required in the regents rules 30-3.10. Once certified by SLL BOCES, all evaluators in the District will utilize ongoing training materials provided through LEAF Subscription Service of NYCOSS. Each year, certified evaluators will attend SLL BOCES sponsored sessions in order to become recertified. These sessions will focus upon continued calibration of evaluators, ensuring inter relater agreement and inter relater reliability. All evaluators will participate in these yearly sessions to become re-calibrated. Based upon their participation in these activities, District all evaluators will be certified by the Superintendent and Board of Education as lead evaluators and evaluators. The minimum duration of the annual re-certification training will be six hours.

The initial training will be a minimum of two days. The District will also utilize ongoing training materials. These sessions will focus upon continued calibration of all evaluators, ensuring inter rater reliability. All evaluators will participate in these yearly sessions to become re-calibrated. Based upon their participation in these activities, all evaluators will be certified by the Board Of Education as lead evaluators and evaluators.

All evaluators will participate in the teacher evaluator training series that has been offered through the St. Lawrence-Lewis BOCES.

Each year, certified evaluators will attend SLL BOCES sponsored sessions in order to become re-certified. These sessions will focus upon continuing calibration of evaluators, ensuring inter-rater agreement and inter-rater reliability. All evaluators will participate in these early yearly sessions to become recalibrated.

All evaluators will also participate in the two full days of Marzano framework instruction, focused on inter-rater agreement and inter-rater reliability. These sessions are led by trainers from Learning Sciences International who are deeply familiar with hte Marzano framework. All have also participated in (and will continue to participate in) training from NorthEast Regional Information Center (NERIC) staff on the use of iObservation electronic platform (within which the district) will house its Marzano framework rubrics, instruments, and evidence.

- Assure that beginning in the 2019-20 school year, the entire APPR will be completed for each teacher or principal as soon as practicable, but in no case later than September 1 of the school year next following the school year for which the classroom teacher or building principal's performance is being measured;
- Assure that beginning in the 2019-20 school year, the district or BOCES shall compute and provide to the
 teacher/principal their score and rating on the Student Performance category, if available, and for the Teacher
 Observation category or Principal School Visit Category of a teacher's or principal's annual professional performance
 review, in writing, no later than the last day of the school year for which the teacher or principal is being measured,
 but in no case later than September 1 of the school year next following the school year for which the teacher's or
 principal's performance is measured;
- Assure that the APPR Plan will be filed in the district office and made available to the public on the district's or BOCES'
 website no later than September 10th of each school year, or within 10 days after the plan's approval by the
 Commissioner, whichever shall later occur;
- Assure that accurate teacher and student data will be provided to the Commissioner in a format and timeline prescribed by the Commissioner;
- Assure that, during the 2015-16 through 2018-19 school year, the district or BOCES will continue to report both the
 original and transition individual category and subcomponent scores and the overall original and transition ratings to
 the State for each classroom teacher and building principal in a manner prescribed by the Commissioner;
- Certify that the district provides an opportunity for every classroom teacher and building principal to verify the subjects and/or student rosters assigned to them;
- Assure that teachers and principals will receive timely and constructive feedback as part of the evaluation process;
- Assure that any training course for lead evaluator certification addresses each of the requirements in the regulations, including specific considerations in evaluating teachers and principals of English language learners and students with disabilities;
- Assure that, during the 2015-16 through 2018-19 school years, any educators who receive a Developing or Ineffective
 rating as their overall transition rating will receive a Teacher Improvement Plan or Principal Improvement Plan, in
 accordance with all applicable statues and regulations, by October 1 in the school year following the school year in
 which such teacher's or principal's performance is being measured or as soon as practicable thereafter.
- Assure that, beginning in the 2019-2020 school year, any educator who receives a Developing or Ineffective rating on their original overall rating pursuant to this APPR plan will receive a Teacher Improvement Plan or Principal Improvement Plan, in accordance with all applicable statutes and regulations, by October 1 in the school year following the school year for which such teacher's or principal's performance is being measured or as soon as practicable thereafter;
- Assure that such improvement plan shall be developed by the superintendent or his/her designee in the exercise of
 their pedagogical judgment, and shall be subject to collective bargaining to the extent required under Article 14 of the
 Civil Service Law;
- Assure that all evaluators and lead evaluators, including independent evaluators and peer evaluators, as applicable, will be properly trained and that lead evaluators will be certified and recertified as necessary in accordance with all applicable statutes and regulations;
- Assure that the district or BOCES has collectively bargained appeal procedures that are consistent with the statute and regulations and that they provide for the timely and expeditious resolution of an appeal to the district/BOCES;
- Assure that, for teachers, all observable NYS Teaching Standards/Domains of the selected practice rubric are assessed
 at least once a year across the total number of annual observations and, for principals, all observable ISLLC 2008
 Leadership Standards/Domains of the selected practice rubric are assessed at least once a year across the total
 number of annual school visits;
- Assure that it is possible for a teacher or principal to obtain each point in the scoring ranges, including 0, for each subcomponent and that the district and BOCES shall ensure that the process by which weights and scoring ranges are assigned to subcomponents and categories is transparent and available to those being rated before the beginning of each school year;
- Assure that if a second measure for the Student Performance category is locally selected, then the same locally selected measures of student growth across all classrooms in the same grade/subject in the district/BOCES must be used in a consistent manner to the extent practicable;
- Assure that all growth targets represent a minimum of one year of expected growth, as determined by the superintendent or another trained administrator;
- Assure that any material changes to this APPR Plan will be submitted to the Commissioner for approval by March 1 of
 each school year, on a form prescribed by the Commissioner, to the Commissioner for approval;
- Assure that the alternate SLOs described in Tasks 2 and 7 of this APPR plan will be used as the basis for certain teachers' and principals' transition APPR scores and ratings, where applicable and consistent with section 30-3.17 of

the Rules of the Board Regents, during the 2016-17 through 2018-19 school years only;

- Assure that, beginning in the 2019-20 school year, no transition scores and ratings will be generated and the district or BOCES' original APPR Plan will apply to all classroom teachers and building principals as defined in the statute, regulations, and SED guidance without any modifications, substitutions, or replacements as a result of the requirements of §30-3.17 of the Rules of the Board of Regents;
- Assure that the district or BOCES will provide the Department with any information necessary to conduct annual monitoring pursuant to Subpart 30-3 of the regulations;
- Assure that the amount of time devoted to traditional standardized assessments that are not specifically required by
 State or Federal law for each classroom or program of the grade does not exceed, in the aggregate, one percent of the
 minimum in required annual instructional hours for such classroom or program of the grade; and
- Assure that the amount of time devoted to test preparation under standardized testing conditions for each grade does
 not exceed, in the aggregate, two percent of the minimum required annual instructional hours for such grade. Time
 devoted to teacher administered classroom quizzes or exams, portfolio reviews, or performance assessments shall not
 be counted towards the limits established by this subdivision. In addition, formative and diagnostic assessments shall
 not be counted towards the limits established by this subdivision and nothing in this subdivision shall be construed to
 supersede the requirements of a section 504 plan of a qualified student with a disability or Federal law relating to
 English language learners or the individualized education program of a student with a disability.
