Any issue not raised in the written appeal shall be deemed waived. All evidence or other information provided by the teacher shall be taken into consideration.

The Superintendent of Schools or his/her designee shall render a written determination in response within 15 school days of receipt of the appeal. The determination of the Superintendent of Schools or his/her designee as to the substance of the annual professional performance review shall not be grievable and arbitrable. However, the following items may be resolved through this appeals procedure or the grievance machinery of the contract:

- compliance with any applicable locally negotiated procedures, as required under Education Law 3012-d and Subpart 30-3 of the Commissioner's Regulations;
- 2. the school district's issuance and/or implementation of the terms of a Teacher Improvement Plan (TIP) under Education Law 3012-d and Subpart 30-3 of the Commissioner's Regulations; and

The District will ensure that all evaluators, including lead evaluators, evaluators, and independent observers are properly trained and certified to complete all teacher evaluations for APPR purposes. Training for all evaluators will replicate the recommended State Education Department model certification process incorporating the Regulations enacted to implement Education Law Section 3012-d.

All evaluators attend a three-day New Teacher Evaluator institute through our local BOCES. Recertification of all evaluators occur in the following ways:

- · Full-day evaluator orientations in late summer prior to school opening
- · Fall and Spring evaluator workshops each three hours in length
- · Monthly Leadership Team meetings each three hours in length
- Outside consultants providing targeted professional development specific to the manner in which the nine required elements are observed and assessed. These are full-day workshops.

Trainings will include the following areas:

1. New York State Teaching Standards and ISSLC Standards

Conduct multiple meetings for all evaluators to review and discuss. Follow-up discussions with all evaluators during each school year to resolve any differences of perspective and to ensure inter-rater reliability. Training will be provided a minimum of once per year in all subsequent years.

2. Evidence-Based Observation and Application and Use of State Approved Teacher Rubric (Danielson 2007)

All evaluators will participate in OASYS training in use of Danielson 2007 rubric, as well as the nine elements of Regents Rule 30-3.10. Board of Education approval by resolution and Superintendent's recommendation will be used to certify the training of all evaluators.

Small group and whole group meetings of evaluators during each school year to discuss implementation and resolve differences of perspective to further ensure faithful implementation of model and inter-rater reliability.

All new and current evaluators in subsequent years will receive OASYS training. In addition, there will be periodic refresher programs for all evaluators followed up by discussions to ensure that all raters are both fair and similar.

To further increase both fairness and reliability, the superintendent and assistant superintendents for instruction will observe principals observing teachers. The evaluation and coaching of teachers is one of a principal's most important responsibilities. This will be reinforced with direct participation in using the Danielson 2007 framework in observations and in pre and post conferences.

3. Application and Use of Student Growth Percentile Model Data

The Superintendent and District CIO are members of the NYS DATAG professional organization. Professional development activities are regularly attended and turn-keyed to the District's evaluators.

4. As needed, outside consultants with expertise in specific areas will be used by Massapequa at the recommendation of the teachers and evaluators closest to the instructional area under the overall direction of the assistant superintendents of instruction.

5. Use of the Statewide Instructional Report System

The District's CIO and Executive Assistant for Student Information Services will attend all workshops conducted by Nassau BOCES. They will provide training and assistance to all evaluators.

6. Scoring Methodology Used to Evaluate Teachers and Principals

All instructional staff will receive access to the full copy of the APPR Plan as approved by the State. Specific workshops on teacher/principal rating will be conducted by the District, the Massapequa Federation of Teachers (MFT) and the Massapequa Association of Administrators.

7. Specific Considerations in Evaluating Teachers and Principals of English Language Learners (ELL/ENL) and Students with Disabilities (SWD's)

Procedural issues relative to the annual professional performance review shall be subject to the grievance machinery of the contract. The following procedural issues may only be appealed through the grievance machinery of the contract:

compliance with any applicable locally negotiated procedures, as required under Education Law 3012-d and Subpart 30-3 of the Commissioner's Regulations; and

All evaluators, including lead evaluators, evaluators, and independent evaluators, receive training sponsored in-district on the MPPR and Danielson Frameworks from an outside consultant. This helps all evaluators to deepen their understanding of each of the domains and promote interrater reliability. This training is renewed each school year. In compliance with state guidelines, all evaluators receive ongoing training on best practices in effective observation/evaluation, including the nine elements of Regents Rule 30-3.10. This training includes observing numerous video lessons of classroom lessons and the evaluators rated them using the rubric. Observations and school visits will be discussed, critiqued, and compared in order to foster consistent rating amongst the evaluators and inter-rater reliability.

Consultants will provide mandatory three-hour professional development to all evaluators on an annual basis, with options to participate in further BOCES training sessions as well. In addition, evaluators will be afforded the opportunity to participate in BOCES-sponsored lead evaluator training sessions throughout the year. Newly hired evaluators will participate in these sessions as well as monthly two-hour workshops with the Assistants to the Superintendent for Instruction and HR to orient them to best practices, process and procedure.

All evaluator certification and recertification training include the following:

- · Authentic Tabletop Exercise in observation techniques During summer months three-day workshop
- · Monthly Principal Lead Evaluator meetings three hours each
- Outside consultants providing targeted professional development specific to the manner in which the nine required elements are observed and assessed - full-day workshops.

Initial certification and recertification will occur annually via Board of Education resolution, upon recommendation of the Superintendent of Schools.

The Teacher Improvement Plan (TIP) is a structured plan designed to support teachers in addressing specific concerns in instruction and outlines a plan of action to address these concerns. The purpose of a TIP is to assist teachers to attain effective or highly effective status. The TIP provides assistance and feedback to the teacher and establishes a timeline for assessing its overall effectiveness.

A TIP must be initiated whenever a teacher receives a rating of *developing or ineffective* in a year-end evaluation. Both the teacher and the administrator meet for an evaluation conference at the end of the school year where the *developing or ineffective* evaluation is discussed (Beginning of the school year if State Assessment Data is not released until after close of the school year). A TIP is designed by the building principal in collaboration with the teacher and the President of the Massapequa Federation of Teachers (MFT) or his/her designee. The TIP must be in place on October 1st or as soon thereafter as practical. An initial conference is held at the beginning of the school year where the TIP is discussed, signed and dated at the beginning of its implementation.

During the first quarter, the teacher will be observed by designated members of the leadership team who will concentrate on observing and evaluating goals identified in the TIP. They will meet with the teacher in a timely manner (within 3 school days) to discuss the observations. Written observation summaries will be provided (within 7 school days) and must be signed by both parties. The teacher will have the right to respond to observation summaries and responses will be attached. Additional observations will not take place until this post observation meeting takes place.

After the first quarter, the administration will assess the effectiveness of the intervention and the level of improvement. Based on that assessment, the TIP may be adjusted appropriately to include at least bi-weekly meetings between teacher and administrator(s). Meetings will take place where union representation may be present upon teacher request. At the end of the evaluation period, if the TIP goals are met and the teacher is rated effective or highly effective, it will terminate. The culmination of the TIP will be communicated in writing to the teacher and union

If the teacher is again rated as *developing or ineffective*, a new TIP will be developed by the building principal in collaboration with the teacher and the president of the MFT or his/her designee, and central office administrator. At least one observation during year two, will be conducted by a central office administrator.

The TIP must consist of the following components:

- I. **SPECIFIC AREAS FOR IMPROVEMENT**: Identify specific areas in need of improvement. Develop specific, behaviorally written goals for the teacher to accomplish during the period of the Plan.
- II. **EXPECTED OUTCOMES OF THE TIP**: Identify specific recommendations for what the teacher is expected to do to improve in the identified areas. Delineate specific, realistic, achievable activities for the teacher.

- III. **RESOURCES:** Suggest specific resources available to assist the teacher to improve performance.
- IV. **RESPONSIBILITIES**: Identify responsible administrator(s) and steps to be taken by administrator(s) and the teacher throughout the Plan. Examples: classroom observations of the teacher (at least one by other administrator other than the building principal); supervisory conferences between the teacher and administrator(s); written reports and/or evaluations, etc.

The **Principal Improvement Plan (PIP)** is a structured plan designed to identify specific concerns in instruction and outlines a plan of action to address these concern. The purpose of a PIP is to assist principals to work to their fullest potential. The PIP provides assistance and feedback to the principal and establishes a timeline for assessing its overall effectiveness.

A PIP must be initiated whenever a principal receives a rating of *developing or ineffective* composite APPR composite rating. Both the principal and the superintendent shall meet for an evaluation conference no later five (5) days after the principal receives his/her composite rating. A PIP shall be designed by the principal and the superintendent or his/her designee in collaboration with the president of the MAA or his/her designee over the course of the summer.

The PIP must be in place no later than October 1st or as soon thereafter as practicable of the following school year. An initial conference shall be held at the beginning of the school year where the PIP is discussed, signed and dated at the beginning of its implementation.

The principal must be offered the opportunity for a peer mentor chosen from the MAA. The principal will select the mentor, with the approval of the Superintendent and the MAA President. The mentor and the principal will collaborate during the first quarter. All dealings between the mentor and the principal will be confidential.

After the first quarter of principal/mentor collaboration, the Superintendent will assess, in writing, the effectiveness of the intervention and the level of improvement. Such assessment will be delivered to the principal by no later than ten (10) school days after the first making period ends. Based on that assessment, the PIP may be adjusted appropriately and quarterly meetings between the Superintendent and the principal will continue. Each meeting will result in written documentation from the Superintendent or his/her designee to the principal, no later than two (2) days after the meeting, detailing what was discussed and the guidance and suggestions offered, if any. The Superintendent or his/her designee will provide the principal with a written mid-year evaluation, no later than January 15th. At the end of the year, if the PIP goals are met, it will terminate. The culmination of the PIP will be communicated in writing to the principal. Both parties will sign the PIP at the end of the school year.

If the principal is rated as *developing or ineffective* for any school year in which a PIP was in effect, a new plan will be developed by the principal and the Superintendent in collaboration with the MAA according to these guidelines for the subsequent school year.

The PIP must consist of the following components:

• **SPECIFIC AREAS FOR IMPROVEMENT**: Identify specific areas in need of improvement. Develop specific, behaviorally written goals for the principal to accomplish during the period of the Plan.
