SUBJECT:	English Language Learner (ELL) and Immigrant Student Counts for 2021–22 ESSA Title III Allocations

The New York State Education Department (NYSED) is preparing to calculate 2021-22 ESSA Title III allocations to Local Education Agencies (LEAs) for ELL and Immigrant students. The ELL allocations are based on the combined number of ELL and provisionally-identified ELL students in each LEA in 2020-21. The Immigrant allocations are based on the number of immigrant students in each LEA in 2020-21. The counts of students are effective at the time that the data is pulled. It is very important that NYSED has accurate counts of ELL, provisionally-identified ELL, and Immigrant students for this determination. To allow LEAs to verify counts of ELL, provisionally-identified ELL, and Immigrant students enrolled at public LEAs, a verification report is available in the L2RPT reporting environment. Counts of ELL and Immigrant students attending nonpublic schools will be verified through the IDEx reporting tool. Additional information on provisionally-identified ELLs enrolled in public schools will be collected and verified through the IDEx reporting tool. Please note that in preparing for the administration of the New York State English as a Second Language Achievement Test (NYSESLAT), LEAs may have already reported appropriate ELL codes in the SIRS. It is still important, however, for LEAs to verify ELL student counts as described in this memo.

### The following timeline has been established:

## Beginning the week of May 10, 2021 through June 11, 2021

- LEAs review ELL counts by district and charter school in Level 2 of the Student Information Repository System (SIRS) using the SIRS-652 "Annual Title III Allocation ELL and Immigrant Count" L2RPT report. Data will be refreshed weekly, based on the previous Friday's data submitted to SIRS. If errors are found, LEAs must make corrections to inaccurate public and charter school student data in their local student management systems and ensure that the revised data are loaded into Level 2 of the SIRS by June 11, 2021. Local Level 1 data centers will require data to be submitted earlier than June 11<sup>th</sup> in order to allow sufficient time for processing.
- LEAs report students who have been provisionally-identified as ELL through SIRS by identifying these students with the 0231 ELL Eligible program service code. It is understood that these students will not have NYSITELL scores. Districts reporting provisionally-identified ELL students must also provide information on these students via the IDEx using the "2020-21 Provisionally-Identified ELL" form. The information required to be reported on this form for these students is NYSSIS ID, first name, last name, and date of birth. NYSED will cross reference the data in SIRS with the information reported via the IDEx. Districts must report provisionally-identified ELL students in both SIRS and via the IDEx. LEAs work with nonpublic schools to verify accuracy of ELL counts reported through the IDEx on the Fall

2020 BEDS Online Report Nonpublic form. LEAs should alert nonpublic schools that provisionallyidentified ELLs should be included in their counts and ensure that they are included. ### June 14, 2021

• ELL, provisionally-identified ELL, and Immigrant counts by public district and charter schools in Level 2 of the SIRS and nonpublic school ELL and Immigrant counts by district in BEDS on June 14, 2021 will be used for 2021-22 Title III ELL allocations.

## End of June 2021 to early July 2021

Local Education Agencies (LEAs) should work with nonpublic schools to ensure that inaccurate data are corrected:

- Counts of ELL students attending nonpublic schools are reported by nonpublic schools on Item 6A of the
  Fall 2020 Nonpublic BEDS form. LEAs should alert nonpublic schools that provisionally-identified ELLs
  should be included in their counts and ensure that they are included. Nonpublic schools with incorrect
  ELL counts, including provisionally-identified ELLs that need to be added to the ELL count, should scan
  corrected ELL counts for Item 6A of their Fall 2020 BEDS Report of Nonpublic Schools form and email them
  to the NYSED Office of Information and Reporting Services (IRS) at <u>datasupport@nysed.gov</u> with the
  subject line "Nonpublic BEDS ELL correction." Corrections require the principal's signature and date.
  Nonpublic school ELL counts should reflect students who were enrolled on BEDS day, October 7, 2020.
- Counts of immigrant students attending nonpublic schools are reported on Item 2 of the Fall 2020 District BEDS form. LEAs with incorrect nonpublic immigrant counts should scan corrected immigrant counts for Item 2 of their Fall 2020 BEDS School District Summary form and email them to the NYSED Office of Information and Reporting Services (IRS) at datasupport@nysed.gov with the subject line "BEDS District Summary correction Immigrants enrolled in nonpublic schools." Corrections require the Superintendent's signature and date. Nonpublic school immigrant counts should reflect students who were enrolled on BEDS day, October 7, 2020.

# <u>Business Rules for extracting ELL and Immigrant data from the Student Information Repository System</u> (SIRS) to provide counts to be used for allocation of ESSA Title III funds

- Rules specified in this document pertain to public and charter school data extracts. BEDS data are the source for nonpublic school ELL and Immigrant student counts.
- Students must have an enrollment record in the 2020-21 school year with one of the following enrollment codes:

0011	Enrollment in building or grade
5544	Transferred in under the ESEA Title I "School in Improvement Status" transfer option
7000	Transferred in under the ESEA "Persistently Dangerous School" transfer option
7011	Transferred in under the ESEA "Victim of Serious Violent Incident" transfer option

If a student has enrollment records for multiple LEAs in the 2020-21 school year, use the enrollment record with the latest beginning enrollment date. A student should only be counted as an ELL or immigrant for a single LEA.

- Include all of the following grade levels in school counts
  - a. For ELL students: K (half-day KH and full-day KF kindergarten) through grade 12, ungraded elementary (13), and ungraded secondary (14).
  - b. For Immigrant students: PK, K (half-day KH and full-day KF kindergarten) through grade 12, ungraded elementary (13), and ungraded secondary (14).
- Students must have a 0231 ELL Eligible program service code in order to be counted for ELL allocations, including students provisionally-identified as ELL.
- Students must have an 8282 Immigrant Children and Youth Status program service code in order to be counted for Immigrant allocations. Immigrant children and youth are defined as individuals who:
  - a. are aged 3 through 21;
  - b. were not born in any State; and
  - c. have not been attending one or more schools in any one or more States for more than 3 full academic years. The months need not be consecutive. "State" means the 50 states, the District of Columbia, and the Commonwealth of Puerto Rico. Children born to U.S. citizens abroad (including those born on military bases), the U.S. Virgin Islands, Guam, or any other U.S. territory that is not D.C. or Puerto Rico are considered immigrants.
- If a student has any of the following ending reasons on his or her enrollment record, the student WILL NOT be included in the count for the LEA.

170	Transferred to another NYS public school outside this district with documentation.
204	Transferred to a NYS nonpublic school with documentation
255	Transferred to home-schooling by parent or guardian
5927	Leaving a school under ESEA – a victim of a serious violent incident
5938	Leaving a NYC community district under ESEA – a victim of a serious violent incident
323	Transferred outside district by court order
430	Excluded pursuant to PHL 2164
442	Left the U.S. (and did not return to the U.S. on the date these data were retrieved)

459	Deceased
221	Transferred to a school outside NYS with documentation.
136	Reached maximum legal age and has not earned a diploma or certificate
8338	Incarcerated student, no participation in a program culminating in a regular diploma.
1089	Transferred to an approved GED program outside this district
799	Graduated (earned a Regents or local diploma)
085	Earned commencement credential
629	Previously earned commencement credential or IEP

• Students who have an enrollment record during the 2020-21 school year that ended with any of the following ending reasons *WILL* be counted as an ELL or Immigrant student for the LEA.

153	Transferred to another school in this district or to an out-of-district placement
238	Transferred to homebound instruction provided by this district

• Students reported with the following ELL exit program service codes during the 2020-21 school year will *NOT* be counted as an ELL for the LEA.

3045 ELL Eligibility Exit based on review of identification determination

• Students reported with one of the following ELL exit program service codes during the 2020-21 school year *WILL* be counted as an ELL for the LEA.

3011	ELL Eligibility Exit Using NYSESLAT score only
3022	ELL Eligibility Exit Using NYSESLAT score and a NYSTP or Regents score
