This notice is to inform you that on August 16, 2016 the New York State Board of Regents received an application to establish a charter school in the Homer Central School District.

Please note that pursuant to Education Law section 2857(1) and 8 NYCRR 119.4 (available at <u>http://www.p12.nysed.gov/psc/publichearing.html</u>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing application. These hearings, which are required to be held within the community that is potentially impacted by the charter school, must be held within 30 days of your receipt of this letter.

Please provide the following required documentation:

- A copy of the public hearing notice must be provided to the Charter School Office at the time of dissemination.
- No later than the next business day following the hearing, written confirmation that this hearing was held must be sent to the Charter School Office.
- Copies of any and all written records or comments generated from this hearing must be sent to the Charter School Office within 15 business days after the hearing.

All documentation listed above should be submitted electronically to <u>charterschools@nysed.gov</u> (the subject line of the email should include the NAME OF PROPOSED CHARTER SCHOOL *Public Hearing*).

In addition, the Board of Regents welcomes your comments on the proposed charter school, including those related on the programmatic and fiscal impact of the proposed charter school or other public and non-public schools in your district. Comments should be submitted no later than November 9, 2016 to <u>charterschools@nysed.gov</u> (the subject line of the email should read: School District Response to Charter School *Application*).
