LETTER OF INTENT TO APPLY

I. Applicant Group Information

- a. Applicant Group. See Table 1, attached.
- b. Public Contact: Mirza Tihic, Ph.D., emeraldcharter@gmail.com
- **c. Application History:** Peter Kozik has been a previous board member for Greater Works Charter School, proposed on July 7th, 2014 to the Board of Regents of the State of New York. The Board of Regents did not grant a charter for the school. The remaining members of the Founding Board have no history of applying for charter schools in New York State.

II. Proposed Charter School Information

- a. Proposed school name: Emerald Charter School
- **b. Proposed school mission statement:** To foster students' desires and abilities for critical inquiry, creativity, civic engagement, and environmental stewardship.
- **c. Proposed school location:** Emerald Charter School will be located in Syracuse, NY in Syracuse City Schools District. Emerald will not be co-located in public school district facilities.
- **d.** Target population/community served: The Emerald School aspires to be a preeminent and inclusive secondary school serving under-engaged students in Syracuse, NY. An under-engaged student is a students who struggles in the traditional school setting, which leads to lack of attention, disinterest, pessimism, and lack of passion for learning. As a result, students are not motivated to learn and progress in their education. In the Syracuse City School District for the 2018 cohort, 752 students graduated with either Regents or Local Diplomas or with "sufficient credit" out of a possible 1,460 students. This left nearly a majority of the cohort, 708 students, without an on-time diploma. Although the official drop-out rate for the district is 247 students (17%) and 334 (23%) students "remain enrolled," the engagement rates for many of these students are weak at best. Emerald Charter School is designed to engage these students and help them thrive.

- **f. Proposed management and/or partner organization(s):** Emerald Charter School is not working and it is not affiliated with a charter management organization. Emerald does not plan to be affiliated with a charter management organization.

- h. School overview:

The foundational design elements of Emerald Charter School are as follows:

1. Humanities Curriculum

Unlike conventional high schools, the Emerald Charter School (Emerald) engages students in an interdisciplinary study of the Humanities. The school will inspire students to explore unfamiliar cultures and challenge their assumptions about their own. Using the project-based learning method of education, Emerald students learn to think critically, read analytically, speak articulately, and write persuasively.

2. Cultural and Community Focus

As the local population grows increasingly diverse, creating a link between home and school becomes more and more important. Creating a link between home and school can enrich all kinds of lessons. The Emerald students will be empowered to learn and experience the rich diversity and inclusion their community offers. Both diversity and inclusion increase the richness of ideas, creative power, problem-solving ability, and respect for others.

3. Experiential and Expeditionary Learning

Emerald focuses on teamwork, courage, and compassion with an active approach to learning. Experiential and expeditionary learning means learning by doing and moving outside the confines of the school to engage with the experiences of others. Emerald first immerses students in an experience and then encourages reflection about the experience to develop new skills, new attitudes, or new ways of thinking.

4. The Primacy of Self-Discovery

Emerald will provide its students opportunities for self-discovery. Through projects and class activities students will uncover and realize their 'grand passions.' At Emerald the students will undertake tasks that require perseverance, fitness, craftsmanship, imagination, self-discipline, and significant achievement. These tasks will provide the students with the opportunity of self-effacement in the common cause.

5. Career and Technical Education (CTE)

To deliver on our vision of student engagement and achievement, students will be taught CTE tracks focusing on business (i.e. project management, entrepreneurship skills), information technology (i.e. coding), and arts, audio/visual technology, and communications. We believe that

this will foster an entrepreneurial mindset and knowledge foundation necessary for the leadership of the 21st century.

III. Enrollment and Retention Strategies

- **a.** Describe the school's strategies to <u>recruit and enroll</u> its students, specifically:
- i. *Those identified in the school's mission*: Emerald recruitment efforts are aimed at the City of Syracuse because its high school graduation rates are significantly lower than the state average (58% vs 80.4%)¹. School representatives will continue targeted community outreach and recruitment efforts to reach both parents and students. The efforts will include information sessions at organizations that offer programs for under-engaged students (e.g. South West Community Center), working with local community boards, local faith organizations, organizations serving children with special needs, cultural and community based organizations (Hopeprint, North Side Learning Center), and social media. Relevantly, the information will be translated in native languages. Students will be enrolled through lottery system.
- ii. *Students with disabilities:* The lottery for Emerald Charter School will ensure that students who are differently abled are represented in its enrollment numbers at the same levels of their representation as in the Syracuse City School District (20%). Emerald has been consulting with Joseph Soule, Ph.D., the coordinator for the OnCampus Program for the Syracuse City School District that is a program affiliated with The Lawrence B. Taishoff Center for Inclusive Higher Education at Syracuse University. We want to understand the needs and accommodations for students with disabilities. Dr. Soule will continue to advise and guide the Emerald's board to work collaboratively with other organizations that serve students with disabilities and the local district Committees on Special Education to help raise awareness about Emerald's services, programs, and settings for students with disabilities.
- iii. *Multilingual Learners/English Language Learners*: The lottery for Emerald Charter School will ensure that students who are English Language Learners are represented in its enrollment numbers at the same levels of their representation as in the Syracuse City School District (19%). Emerald will continue its relationship and community outreach in partnership with organizations that serve the newcomer and immigrant population such as Interfaith Works, Catholic Charities, North Side Learning Center, and Hopeprint to reach this population. The outreach materials (information about the school, how to apply to Emerald, contact info) will be made available in native languages and translators will be present at information sessions at various community locations (mosques, churches, temples, libraries, and clubs/associations).
- iv. *Economically disadvantaged students:* Emerald will distribute information about the school with local organizations working with economically disadvantages students such as shelters, foodbanks, community centers, and houses of worship. In addition to distributing materials, Emerald plans to hold information sessions to address parent and community

members' questions related to school and the application process. This will ensure that we effectively recruit students form diverse economic background.

- **b.** Describe the school's strategies to <u>retain</u> its students, specifically:
- i. *Those identified in the school's mission:* The Emerald's curriculum and program is designed to engage and support students of all levels of proficiencies through project based learning, peer support, crisis intervention counseling, mentoring, after school assistance, and parental involvement. Emerald will not only create an individualized education program/plan for the students; moreover, the school will create a family plan to support the student's education, growth, and development.
- ii. *Students with disabilities*: Emerald will be a fully inclusive secondary school. Special Education teachers and professionals will be part of the school's design and implementation. All classes will utilize a co-taught model of instructional delivery. Teaching Assistants will be deployed as appropriate. Consistent with our curriculum and program, students with disabilities will benefit from the services listed above. Furthermore, additional targeted interventions for students with special needs will be offered in accordance with their individualized and family education plan. Where needs arises, we will contract with local resource providers such as social workers, speech therapist, physical therapist, and others to provide necessary special needs services.
- iii. *Multilingual Learners/English Language Learners*: One of Emerald's educational design elements is cultural and community focus. In our public outreach the parents voiced their concerns that their children were losing the culture and their identity and advocated for education that is inclusive of different cultures and languages. Emerald will include foreign language in its curriculum and program offering. Furthermore, Emerald will partner with organizations such as North Side Learning Center to offer adult classes for parents on parental advocacy for their children and classes related on best practices to preserve ones cultural heritage. Additionally, parents will be invited to board meetings and town hall meetings, where translators will be available. Finally, school communication material to the parents, will be translated into the predominant languages of the communities served.

As a fully inclusive secondary school, Teachers of English as a Second Language will be part of the school's implementation. Classes will utilize a co-taught model of instructional delivery where appropriate, content area teachers will be educated in methods of teaching English Learners, and first language skills will be leveraged to ensure student achievement. Partnerships for teacher's professional development include working with SupportEd of Washington, D.C. which has provided professional development for the Syracuse City School District. The Founding Board is investigating a partnership with Voxy (voxy.com) to provide additional career and technical education support for English Learners.

iv. *Economically disadvantaged students.* Consistent with our curriculum and program, economically disadvantaged students will benefit from the services listed above under i.. Furthermore, through our partnerships and after school program students will be enriched through a community based approach and given an additional support in achieving its individualized and family education plan. It is our belief that an individualized and family

oriented education plan promotes development of skills, capabilities, abilities that both children and parents need to succeed personally and consequently academically. Thus, the family empowerment will enable us to retain them.

IV. Public Outreach and Community Support

- a. See Table 2, attached. Table 2 outlines our public outreach and feedback collected, which informed our board regarding the needs and gaps in current educational offerings. Further, the community/public outreach served as a medium to inform the larger public about the Emerald Charter School and address any questions and/or concerns that the public had. Following is the list of different means we used to inform and reach out to the public:
 - i. Website: we created a website <u>http://emeraldcharter.org/</u>. It provides information about the school and allows the public to reach out to us.
 - ii. Press release. Sent to Syracuse.com, News Times, and posted on Emerald's Facebook site to inform media and community of the intent to open a new charter school (See attachment 1).
 - iii. Social media: created a Facebook site https://www.facebook.com/EmeraldCharter/ (211 followers).
 - iv. Community Public Forum notifications. Flyers distributed in the community and posted on Facebook and Nextdoor.com (See attachment 2).
 - v. Community Public Forum PPT presentation (see attachment 3). Used survey to collect input from parents (see attachment 4).
 - vi. Recorded a video to address questions that arose and explain who is involved with the Emerald School. Video is posted on Emerald's Facebook site (Video reached 1173 people, and had 510 views).
 - vii. We asked for letters of support (see attachment 5).
- b. The initial assessment indicates that the parents and children are interested in our proposed charter school. Furthermore, our community outreach helped us identified gaps and needs in education by collecting direct feedback from parents whose children are not engaged and community members who work with children that are not currently engaged in educational settings. Many parents did not understand what a charter school is, hence we included NYS Education Department's definition of Charter School (see attachment 3). Some parents in the community did not speak English and/or had not a good understanding of K-12 education. In this case, translators were used. Throughout the communities, parents and community members asked for a curriculum that engages children, focuses on cultures/communities, and makes them critical thinkers and leaders through a project-based learning experience.

We disseminated surveys (see attachment 4) at the public forums. Overall, out of 47 completed surveys, a vast majority or 72.8% (35.6% agree, 42.2% strongly agree) of survey takers supported the effort of Emerald Charter School, where 15.6% neither agreed nor disagreed, and only 6.7% disagreed. Similarly 72.3% (19.1% agree, 53.2% strongly agree) of survey takers would like to see Emerald Charter School open in Syracuse, NY. This information is noteworthy as 53.2% "strongly agree" to see Emerald open.

Overall, the parents were excited about the presentations and the fact that the school will focus on cultural experiences and expeditionary learning within the community. Further, parents and community leaders were excited about the inclusion of family in the children's education and making a family education plan. They were happy to see that we use a collaborative approach in education and that we are collaborating with other resource providers to offer after-school programming, mentoring, and support.
