**Proposed Revision(s):** Requesting a revision to:

- Reduce the authorized enrollment from the currently approved 430 students to 330 students beginning in the 2021-2022 school year.
- Replace existing key design elements: "Small School Design"; "Data-Driven Culture"; "Culturally Responsive Teaching with an Emphasis on Social Justice"; and "More Time" with the following key design elements: "Scholar-Centered and Inclusive Learning Environment"; "Social Justice"; and "Constructivist Approach to Math and Balanced Literacy."

The application of this school is being reviewed for possible action at an upcoming Board of Regents meeting.
