Public school districts and consortia of districts or district(s) and BOCES were eligible to apply. Applicants must give Religious and Independent Schools within their boundaries the opportunity to participate and allow them to have meaningful and substantial involvement in the development of the proposal.





Learning Technology Grant program participants are expected to develop, implement, and share programs, activities, and materials designed to:

- facilitate the delivery of quality instruction,
- increase equitable access to high-quality learning experiences,
   and
- promote culturally- and linguistically-responsive learning environments for all students through using educational technology.



Programs must address one (or a combination) of the following Focus Areas:

- Personalized Learning
- Online, Blended, and/or Distance Learning
- Professional Development on Topics Related to Educational Technology





- As required by CRR Section 144.8, NYSED must sponsor a meeting at which all grant recipients share what they have learned and the programs they have developed during this grant period, with grant funds.
- As part of this requirement, each of the 2018 LTG recipients will participate in one of the panel discussions.
