- (2) the district's adherence to the standards and methodologies required for such reviews, pursuant to Education Law §3012-d and Subpart 30-3 of Commissioner's regulations;
- (3) the adherence to the regulations of the Commissioner and compliance with any applicable locally negotiated procedures, as required under Education Law §3012-d; and 126
- (4) the school district's issuance and/or implementation of the terms of the teacher improvement plan under Education Law §3012-d and this Subpart (i) only improvement plans created as a result of this APPR plan may be appealed.

Appeal procedures shall provide for the timely and expeditious resolution of any appeal.

An evaluation that is the subject of an appeal shall not be sought to be offered in evidence or placed in evidence in any proceeding conducted pursuant to Education Law §3020-a and §3020-b or any locally negotiated alternate disciplinary procedure until the appeal process is concluded.

Appeals of annual professional performance reviews should be limited to those that rate a teacher as Ineffective or Developing only.

A teacher may not file multiple appeals regarding the same performance review or teacher improvement plan. All grounds for appeal must be raised with specificity within one appeal. Any grounds not raised at the time the appeal is filed shall be deemed waived.

- · Any tenured teacher who receives an overall rating of "Developing" may file an appeal with their Lead Evaluator.

The performance review and/or improvement plan being challenged must also be submitted with the appeal. Any information not submitted at the time the appeal is filed shall not be considered.
- A teacher must file the appeal within ten (10) school days of receipt of the final evaluation.
- The Lead Evaluator must render a written decision within ten (10) school days of receipt of the appeal.
- If the Lead Evaluator upholds the decision, the teacher may then continue the appeal process to a five (5) member Appeals Committee.
- If the teacher decides to further the appeal to the Appeal Committee (Panel), he/she must do so within ten (10) school days of receiving the written
  decision from the Lead Evaluator.
- The Appeal Committee will be picked from STA members that are current members of the District APPR Committee and District administrators. The Committee will be knowledgeable on the details of the District APPR.
- The five (5) member Appeals Committee will consist of two (2) members picked by the STA and two (2) members picked by the Superintendent of Schools or his designee. The fifth member will be mutually agreed upon by the four members picked for the Committee.

- 2. The school district's or board of cooperative educational services' adherence to the standards and methodologies required for such reviews;
- 3. The adherence to the Commissioner's regulations, as applicable to such reviews;
- 4. Compliance with any applicable locally negotiated procedures applicable to annual professional performance reviews or improvement plans; and
- 5. The school district's or board of cooperative educational services' issuance and/or implementation of the terms of the principal improvement plan.

#### RATINGS THAT MAY BE APPEALED

Appeals of annual professional performance reviews may be initiated by any principal for ineffective and developing ratings or any rating tied to compensation. An appeal may only be initiated once a principal receives the overallrating.

#### PROHIBITION AGAINST MORE THAN ONE APPEAL

A principal may not file multiple appeals regarding the same performance review. The issuance of an improvement plan may prompt an appeal independent of the performance review. The implementation of an improvement plan may be appealed upon each alleged breach thereof. All grounds for appeal must be raised with specificity within such appeal. Any grounds not raised shall be deemed waived.

#### TIME FRAME FOR FILING APPEAL

All appeals shall be filed in writing. The act of mailing the appeal shall constitute filing. An appeal of a performance review must be filed no later than fifteen (15) business days of the date when the principal receives their final and complete annual professional performance review. If a principal is challenging the issuance of a principal improvement plan (implemented under the guidelines of this agreement), appeals must be filed with fifteen (15) business days of issuance of such plan. An appeal of the implementation of an improvement plan (implemented under the guidelines of this agreement) shall be within fifteen (15) business days of the failure of the district to implement any component of the plan. The failure to file an appeal within these timeframes shall be deemed a waiver of the right to appeal and the appeal shall be deemed abandoned. An extension of the time in which to appeal may be granted by the Superintendent upon written request. When filing an appeal, the principal must submit a written description of the specific areas of disagreement overhis or her performance review, or the issuance and/or implementation of the terms of his or her improvement plan. Supportive evidence about the challenges may also be submitted with the appeal. Any additional documents or materials relevant to the appeal must be provided by the district upon written request for same. The performance review and/or improvement plan being challenged must also be submitted with the appeal.

#### TIME FRAME FOR DISTRICT RESPONSE

Within ten (10) business days of receipt of an appeal, the Superintendent must submit a detailed written response to the appeal. The response must include all additional documents or written materials relevant to the point(s) of disagreement that support the district's response. Any such information that is not submitted at the time the response is filed shall not be considered on behalf of the district in the deliberations related to the resolution of the appeal. The principal initiating the appeal shall receive a copy of the response filed by the school district, and all additional information submitted with the response, at the same time the school district files its response. The Superintendent's response shall be the final decision for untenured principals and tenured principals that are appealing a Developing rating, and any appeals in regards to an Improvement Plan. Tenured principals that are appealing an Ineffective rating may appeal to a hearing officer. If a tenured principal is appealing further, additional material supporting the challenges may be submitted by the principal up to five (5) business days before the date of the hearing.

#### DECISION PROCESS FOR APPEAL

- 1. Appeals for an Ineffective rating will be heard by either the Ulster BOCES District Superintendent or Deputy Superintendent. The hearing shall be held in a timely manner after the appeal is made, but in no event shall it be less than ten (10) business days or no more than twenty (20) business days after the receipt of the Superintendent's response. The parties shall have the ability to be represented by either legal counsel, union representation, or appear pro se. The appeal shall not be open to the public. The hearing officer will meet separately with the District and principal. A written decision on the merits of the appeal shall be rendered no later than ten (10) business days from the close of the hearing. The decision shall set forth the reasons and factual basis for the determination on each of the specific issues raised in the appeal. The hearing officer must either affirm, set aside, or modify a district's rating or improvement plan. A copy of the decision shall be provided to the principal and the district. The decision of the hearing officer shall be final and binding in all regards and shall not be subject to review at arbitration, before any administrative agency or in any court of law except as provided for in #2 below.
- 2. Notwithstanding the above, in the event that a tenured principal has received two consecutive ineffective and/or developing APPR evaluation ratings after the above procedure has occurred, the principal shall have ten (10) business days to appeal the decision to an arbitrator, mutually agreed

upon by the District and principal, who shall make a final and binding decision upon the appeal of the APPR evaluation and/or the PIP on a timely and expeditious basis. The District and Association shall maintain a list of no less than three (3) mutually agreed uponarbitrators. The documentation to be furnished to the arbitrator on behalf of the principal and by the District shall be exchanged between the principal and the administration within ten (10) business days from the time of submission to the arbitrator. In the event that either party has a question regarding the authenticity of such documentation, the same shall be presented in writing immediately to the arbitrator and copied to the other party for the arbitrator's review and consideration.

- 3. The arbitrator shall hear appeals in a timely manner after the appeal is made. The parties shall have the ability to be represented by either legal counsel, union representation, or appear pro se. The parties shall exchange an anticipated witness list no less than five (5) business days before the scheduled hearing date. The district shall have the opportunity to present its case supporting the rating or improvement plan and then the principal may refute the presentation. These may include the presentation of material, witnesses and/or affidavits in lieu of testimony. The standard of review to support the evaluation or the PIP shall be "clear and convincing evidence" of the propriety of the same.
- 4. A written decision from the arbitrator on the merits of the appeal shall be rendered in a timely manner after the arbitration hearing. The decision shall set forth the reasons and factual basis for the determination on each of the specific issues raised in the appeal. The arbitrator must either affirm, set aside, or modify a district's rating or improvement plan. A copy of the decision shall be provided to the principal and the district.
- 5. The entire process shall be timely and expeditious as required under education law 3012d.

#### TEACHER IMPROVEMENT PLAN

Upon rating a teacher as Developing or Ineffective overall through an Annual Professional Performance Review conducted pursuant to Education Law 3012-d and Subpart 30-3 of the Rules of the Board of Regents, a district shall formulate and commence implementation of a teacher improvement plan for such teacher by October 1<sup>st</sup> in the school year following the school year for which such teacher's performance is being measured or as soon as practicable thereafter. Every attempt should be made for the initial meeting to take place no later than fifteen (15) school days after the teachers are due to report for the opening of classes for the school year.

The purpose of the Teacher Improvement Plan (TIP) is to:

- Identify concerns related to professional performance.
- Set goals that focus on improvement/growth.
- Provide administrative assistance.
- Provide accountability for administrator's recommendation(s).

The goal of the Teacher Improvement Plan is to provide support through communication, discussion and collaboration in the area(s) of significant concern. The administrator and teacher will determine strategies or steps to be taken to overcome the deficiencies, but it is agreed that the primary responsibility for overcoming the deficiencies remains with the teacher. The administrator and teacher will agree on a mutual timeline to improve any noted deficiencies.

When a Teacher Improvement Plan is indicated, the following guidelines should be followed:

- 1. The principal will schedule a formal meeting for the purpose of developing the TIP. The teacher will be notified that they are entitled to union representation at this meeting. Other parties may participate in these meetings as warranted by circumstances. A sign-in sheet for those present in the TIP development meeting will be attached to the TIP document.
- 2. The building principal will list areas needing improvement as indicated by the evaluation process on the form provided.
- 3. The building administrator and teacher will list a description of steps or strategies to address the areas needing improvement.
- 4. The building administrator and teacher will list resources, available district materials and workshops to help the teacher improve.
- 5. The building administrator and teacher will agree upon a timeline for the process and a date for the follow-up evaluation.
- 6. Additional observations/meetings between the administrator and teacher will take place as needed.

- 7. The teacher will provide evidence of satisfactory improvement in the designated areas.
- 8. Future evaluations will reflect changes, if any, in the deficiency areas.
- 9. The Teacher Improvement Plan and all records of subsequent observations/meetings/ evaluations will become part of the teacher's evaluation record.
- 10. The TIP will also have a date of completion agreed upon by the teacher and Principal. For a tenured teacher, the timeline for achieving improvement shall be set at one school year or a shorter period of time if mutually agreed upon the Parties. For non-tenured teachers, the timeline for achieving improvement shall be set by the District.
- 11. The TIP is signed and dated at this conference.
- 12. The implementation of the TIP should commence as soon as possible.
- 13. Teachers may comment and submit a written response that will be attached to their TIP document. Every attempt should be made to submit this response within 10 days of the meeting.
- 14. If the goals of the Teacher Improvement Plan are not achieved, the District may take further action with regard to the areas of concern.
