The planned project fulfills the purpose of this grant by improving the facility in a variety of ways: • Increasing access to the outdoors- The current, secure access to the outdoors is accomplished through a vestibule area that does not provide adequate oversight of students and staff coming and going to the building. The current layout does not provide access to all floors for students and staff with physical disabilities. The new enhanced plan dramatically improves supervised access to the building with main office oversight and access to nursing services. The elevator will allow all students and staff physical access to the entire building and all educational, counseling and medical services and programs. • Facilitating physical distancing- The new entrance improves the ability of staff to manage social distancing by providing an improved space with direct sight of students, staff and visitors coming and going to the building. • Enhancing cleaning and sanitization efforts- The current building does not allow for access to all for current, enhanced cleaning efforts and sanitation. The elevator will allow the district to best utilize cleaning equipment on a daily basis to sanitize all areas of the facility. This project will allow the district to maintain operations and continuity of services in our ongoing efforts to prevent and respond to COVID and to emerge stronger post-pandemic as part of our layered approach. The planned construction is for our primary building, which includes all students prekindergarten through second grade, beds code 640801040003. This construction would include renovation to add a new elevator to access the second floor, first floor and basement floor. The building was constructed without elevator access to these floors. Included in this renovation would be reconstructing the front entracne and main office to create a secure vestibule and attendance area at ground level. The entire project cost would be approximately \$1.17M, of which the district would utilize \$644,730 from A
