Riverhead Charter School (RCS) held town hall meetings at the beginning and middle of the school year to engage a variety of stakeholders in discussions regarding programmatic priorities and funding. These stakeholders included board members, instructional leaders, parents, students, community partners, as well as organizations representing underserved students (e.g., students experiencing homelessness and/or in foster care). Since that time our plan remains unchanged in its programmatic and fiscal focus. RCS will continue to involve its stakeholders in the implementation of the ARP by holding regular school family and staff meetings as well as virtual town halls for the broader community. The ARP will remain an agenda item at open Board meetings; RCS will continue to survey students, families, and staff to gather input. As revisions are made to the plan, we will formally solicit public comment.
