The Lewiston-Porter Community was very pleased that the District offered summer school classes for Elementary, Middle and High School students. The program included transportation services, a school nurse, clerical support, and administrative support. At the High School level, three teachers offered credit accrual courses for the students. The funding also provided a Academic Achievement Coordinator, an Elementary Program Coordinator, a School Social Worker and an Alternative Learning Center.

Additionally, all school classroom unit ventilators were equipped with Merv 13 high grade filters. At the Elementary level many classrooms received sensory and kinesthetic desks and flexible seating.
