## **Background and Instructions**

#### Background

Section 9-a of part A of chapter 56 of the laws of 2021, as amended by §5-a of part A of chapter 56 of the laws of 2022 requires, on or before July 1, 2022, <u>every</u> local educational agency (LEA) receiving funding from the Elementary and Secondary School Emergency Relief (ESSER) funding from the American Rescue Plan (ARP) act of 2021 to post on its website and submit to the New York State Education Departent (NYSED) an updated plan of how such funds will be expended and how the LEA will prioritized spending on non-recurring expenses as defined in section 9-a(1) of part A of chapter 56 of the laws of 2021. #### Instructions

The State Budget Reporting Survey is due by July 1, 2022.

LEAs must complete all sections and are required to answer questions marked with a red asterisk. If a required question has not been completed, the business portal will highlight it in red and the section of the application will be flagged. The applicant will be unable to submit the application to NYSED for final review if a required question remains unresolved.

The online application may only be submitted/certified by the chief school officer of the applicant LEA. The designated superintendent (public school LEAs)

or the chief executive officer, board of trustees president, or school employee designated by the board of trustees (charter school LEAs), are the only

administrators with the submit/certify rights necessary to successfully submit and certify a completed application for NYSED review.

LEAs are NOT REQUIRED to send hard copies of survey materials to the Department.

# 2. Please provide an analysis of public comment for the updated American Rescue Plan (ARP) - Elementary and Secondary School Emergency Relief (ESSER) funding.

Since submission, the following stakeholder meetings have occurred:

- Stakeholder meeting on 1/18/22 included representatives from district and elementary administrative teams reviewed school-level iReady Data and highlighted the need for additional phonemic awareness programs and programs focused on reading at the elementary level (Fundations, Heggerty, Wilson Reading). Additional supplies and materials needed to fund new reading programs.
- Stakeholder meeting on 2/9/22 included secondary principals and directors. Highlighted additional supplies and materials needed for Morning Academies
- BOE presentation on 3/9/22 regarding Department of Instruction changes for next school year including grant-funded initiatives planned for the next school year.
- Stakeholder meeting on 3/18/22 included representatives from collective bargaining units, administration, teachers, parents, and community
  members. This meeting reviewed all current supports and programs financed through grants. Feedback focused on how the district would be
  addressing learning deficits from the pandemic, and highlighted new supports based on student data evaluation. Parent members sought additional
  support for mental health, including guidance counselors and psychologists.
