Background and Instructions

Background

or the chief executive officer, board of trustees president, or school employee designated by the board of trustees (charter school LEAs), are the only

administrators with the submit/certify rights necessary to successfully submit and certify a completed application for NYSED review.

The district was unable to hire qualified persons to fill all academic intervention positions. As a result, only three math interention coaches, an ELL teacher and TA, and project coordinator for MTSS were hired and were actually funded through CARES Act funding. Funding summer school for 2021 was taken from the 1% state reserve funds and equaled \$ 23,804 Funding for after school enrichment activities was taken from the 1% state reserve funds and equaled \$7272

2. Please provide an analysis of public comment for the updated American Rescue Plan (ARP) - Elementary and Secondary School Emergency Relief (ESSER) funding.

Two community updates of ESSER funded initiatives were provided at public meetings on November 22, 2021 and March 7, 2022. Community member responses were limited but included frustration with the district's inablity to hire qualified individuals for the reading intervention coach positions and praise for maintaining smaller class sizes for younger students. In addition, student performance data from the math coaching initiative was well received as the measureable outcomes were positive. These efforts were funded through CARES Act funding. ARP/ESSSER III funding will be used in years 2 & 3 of the grant.
