ARP ESSER expenditure reports are presented once per month at our public Board meetings. The district also provides detailed updates on a quarterly basis to the board. As of June 24, these were provided in December 2021, April 2022 and scheduled for July 2022. The July 2022 report will provide year end information for the 21-22 school year. In July 2021 and again in July 2022, the district will solicit additional comments from all stakeholders through an online survey.

At the end of July 2022, the district is holding a leadership retreat that will include board members, administration and teachers. The district plans to review the current strategic plan which focuses on college and career readiness, increase learning opportunities for high school students, addressing the learning loss created in part by the pandemic and solidifying plans for ARP ESSER spending in the 22-23 and 23-24 school years. After this meeting, all possible adjustments/changes will be submitted for approval.

During the 22-23 school year the district is hiring a new elementary guidance counselor four month prior to the retirement of the current elementary counselor to increase counseling services temporarily and facilitate a smooth transition for both the employee and students they serve.	150:2

Summary of New Programs or Expansion of Existing Programs in Current Year	Investment (\$)
During the 2021-2022 school year, the district began an afterschool program to provide both academic and social/emotional support for students. The program is provided by the YMCA of the Twin tiers and provides tutors to support students academically and a recreation/physical education component to support students social/emotional health. The district paid 50% of the cost of the program with parents also providing 50% of the cost.  The district technology coordinator retired in December 2021. To ensure a smooth transition and increase technology srvices for students and staff, the district hired our new technology coordinator in September 2021. From September 2021 through December 2021, we had two 1.0 FTE providing technology coordination.	60557
During the 2021-2022 school year, the district increased a 0.6 FTE health position to 1.0 FTE health/physical education, the additional time was spent to offer increased physical education options for students. This position also allowed us to implement an afterschool strength training program.	22831
During July-August 2021, the district offered summer school on a limited basis due to pandemic restrictions that were in place at the time. Our summer school was provided virtually by BOCES for students needing remediation at the high school level. The district bussed students to school each day and provided teaching and technology support at the school. We did not want home wifi or technology issues to be a deterrent to student learning.	7647
