Background

The applicant will be unable to submit the application to NYSED for final review if a required question remains unresolved.

The online application may only be submitted/certified by the chief school officer of the applicant LEA. The designated superintendent (public school LEAs)

or the chief executive officer, board of trustees president, or school employee designated by the board of trustees (charter school LEAs), are the only

administrators with the submit/certify rights necessary to successfully submit and certify a completed application for NYSED review.

LEAs are NOT REQUIRED to send hard copies of survey materials to the Department.

In response to newly identified needs, the Bolivar-Richburg Central School District has made to following adjustments to their ARP-ESSER Plan:

- Contract with the YMCA of Olean to provide after-school and summer enrichment programming to students experiencing learning loss related to the COVID-19 pandemic. The YMCA iwill provide academic, cultural, and recreation enrichment activities and on-site supervision.
- Added teacher aides to help support student participation in afterschool and summer academic programming. Teacher aides will provide one on one support to students to accelerate learning and mitigate learning loss.

2. Please provide an analysis of public comment for the updated American Rescue Plan (ARP) - Elementary and Secondary School Emergency Relief (ESSER) funding.

The Bolivar-Richburg Central School District continued to solicit feedback on the ARP-ESSER and ARP-SLR plans throughout the year. District parents and families were encouraged to share feedback via the district website and at school board meetings. Faculty and staff were surveyed during departmental meetings. The public was invited to make comments at the school board meeting. Results were tabulated to re-evaluate priorities and plans were revised to meet newly identified needs. The district will continue to solicit input from stakeholders via school board meetings and surveys twice per year and will incorporate feedback as needed.
