Student needs will be measured and monitored throughout the school year. Students with high achievement gaps were identified at the end of last year and were asked to participate in our summer school program. Assessments and data were collected throughout the course of our program utilizing the SANY database. Our database allows each child's progress to be monitored closely and in detail until the student reaches a level of mastery on all standards. Utilizing the standardized learning structure helps teachers to create an intervention plan for each student and group them according to their ability level. This data is then used for targeted interventions within the classroom and through tutoring programs. Students will continue to receive assessments during the course of the year, and teachers will gather data to monitor growth or assign alternate supports. In order to ensure that our school has the ability to offer a wide range of support for our students, we will be using the majority of the funding to employ Academic Intervention Specialists, Speech-Language Pathologist, PBL Teachers, Intervention	1:14
Support Teachers, and ENL, Special Ed. Teachers and Counselors.
