Background and Instructions

Background

Section 9-a of part A of chapter 56 of the laws of 2021, as amended by §5-a of part A of chapter 56 of the laws of 2022 requires, on or before July 1, 2022, <u>every</u> local educational agency (LEA) receiving funding from the Elementary and Secondary School Emergency Relief (ESSER) funding from the American Rescue Plan (ARP) act of 2021 to post on its website and submit to the New York State Education Departent (NYSED) an updated plan of how such funds will be expended and how the LEA will prioritized spending on non-recurring expenses as defined in section 9-a(1) of part A of chapter 56 of the laws of 2021. Instructions

The State Budget Reporting Survey is due by July 1, 2022.

LEAs must complete all sections and are required to answer questions marked with a red asterisk. If a required question has not been completed, the business portal will highlight it in red and the section of the application will be flagged. The applicant will be unable to submit the application to NYSED for final review if a required question remains unresolved.

The online application may only be submitted/certified by the chief school officer of the applicant LEA. The designated superintendent (public school LEAs)

or the chief executive officer, board of trustees president, or school employee designated by the board of trustees (charter school LEAs), are the only

administrators with the submit/certify rights necessary to successfully submit and certify a completed application for NYSED review.

LEAs are NOT REQUIRED to send hard copies of survey materials to the Department.

Brooklyn Prospect Charter School (BPCS) submitted its plan for utilizing ARP-ESSER funds in February 2022 and received NYSED approval for the plan on 2/28/2022. In the four months since NYSED approved its ARP-ESSER application, BPCS has not materially altered its plan for using the funds.

It should be noted that BPCS-CSD 15 is not currently operating any schools and is not scheduled to have any open until the 2023-24 school year. As it begins to plan for the opening of its elementary school, BPCS-CSD 15 will meaningfully engage the stakeholders who comprise its school community and solicit their feedback about how available ARP-ESSER resources should be utilized. BPCS will also continue to incorporate public comment into its evaluations of the ARP-ESSER plan throughout the school year.
