BSNBCS provided multiple opportunities for public comment as a part of the our American Rescue Plan (ARP) - Elementary and Secondary School Emergency Relief (ESSER) planning and subsequent feedback sessions. For all members of the public, the school established a webpage on our school's site that provided information on the ARP plan, with an email address soliciting feedback. For parents, meetings were held that solicited feedback on their priorities on student needs and support due to the pandemic. Additionally, our Open Meetings held by our Board of Trustees included discussion of our ARP plan and an opportunity for public comment. The primary feedback we received were from parents of BSNBCS students who indicated that they wanted funds spent on two main areas: student safety for COVID and additional student academic programs to support learning loss. These were two major priorities of the ARP budget and we continue to monitor these opportunities for public comment as we implement the approved plan.

ARP- ESSER funding was applied to who support mitigation of learning loss by providing direct in- person instruction to students impacted by the pandemic, including literacy support, Response to Intervention Services and differentiated academic interventions for students with disabilities. Each of these instructors teach courses where a majority of at-risk students who are eligible for free and reduced lunch. Our classrooms generally average 26 or 27 students per grade and our co-teaching model typically includes at least two instructors per classroom, providing a per pupil teacher ratio of roughly 1:13 in those classes with two instructors.	1:13
