Program Goal 1 – To maximize in-person instruction time Icahn 5 has identified and invested in sufficient personal protective equipment (PPE) (\$55,786) to ensure a continued safe, secure Icahn 5 learning environment. ARP funds have also been spent to support compliance with COVID-19 safety requirements and protocols with investments in physical safety equipment. PPE supplies have included Sprayers, Desk Shields, thermometers, Disinfectant Supplies, and one Custodial Isolation Suit. Icahn 5 has invested in professional development focusing on the needs of students resulting from the pandemic. Icahn 5 has also invested \$46,216 in afterschool, summer, and extended day programming.	102,002
