grant. Due to COVID-19 constraints, Great Oaks was unable to guarantee fellows in year one. At this	
time the school plans to expense the total funding in the next two funding years. In addition, the school	
will submit a request to amend the ARP-ESSER funding to also support supplemental staff, stipends for	
additional work, and online credit recovery tools. The school was able to use CRSSA funds in 2021-22
