The changes made to the ARP Plan in 2021-22 were mostly related to financial needs versus a change in programming or a shift in the school's overall plan to address learning loss and meet the needs of the school community. For example, the original budget covered the Director of Student Support Services. However, this position is now being covered by another funding source with a shorter grant period. The Virtual Saturday Academy stipends will also no longer be covered by ARP ESSER 3 in this program year. Other minor changes were made due to a difference in projected vs. actual salaries for new staff covered by the grant. Some of this unused funding was reallocated to cover Student Chromebooks as well as training and professional development for staff. The remainder of the unused funding will be in subsequent school years based on identified needs.

The school leadership regularly reviews the ARP Plan to ensure that we are continuing to use the funding to meet student needs as identified by assessment data. We also request feedback from stakeholder groups through the weekly "CheckUP" meetings with parent and community members as well as monthly parent council meetings, the student leadership committee and open montly Board meetings. Although we have not received much public omment on the specific elements of the plan, overall, the response to our efforts to date have been positive.
