## Constitutional Eligibility Questionnaire

Please complete the following questionnaire:

1. Is the institution wholly or in part under the control or direction of any religious denomination?
2. Does the institution receive financial assistance from any religious body?
3. Do the policies of the institution with respect to the selection of members of its governing board, its administrative officers or its faculty provide that the faith or creed of a candidate shall be relevant in any way to his selection?
4. Do the policies of the institution with respect to the admission of students provide that the faith or creed of an applicant shall be relevant in any way to his admissibility to the institution?
5. Do the policies of the institution with respect to the awarding of scholarships, fellowships or other financial assistance to its students provide that the faith or creed of an applicant shall be relevant in any way to the awarding of such assistance?
6. Is any denominational tenet or doctrine taught in the institution?
7. Does the institution award any degree or degrees in the field of religion?
8. Does the institution include within its structure, or is it affiliated with, any seminary or school of theology?
