A. A teacher who receives an ineffective overall APPR rating shall be entitled to appeal their overall APPR rating, or a teacher who received a developing overall APPR rating that is comprised of a highly effective Observation Category rating and an ineffective Student Performance Category rating (i.e. an anomaly), based upon a paper submission to the Superintendent of Schools or the Superintendent's administrative designee, who shall be trained in accordance with the requirements of the statute and regulations and also possesses either an SDA or SDL Certification; provided, however, in the event that the Superintendent or the Superintendent's administrative designee served as an evaluator or lead evaluator he or she shall not hear the appeal.

B. The appeal must be brought in writing, specifying the area(s) of concern, but limited to those matters that may be appealed as prescribed in Section 3012-d of the Education Law. Further, a teacher who is placed on a Teacher Improvement Plan ("TIP") shall have a corresponding right to appeal concerns regarding the TIP in accordance with the requirements set forth in Section 3012-d of the Education Law.

C. An appeal of the APPR or a TIP must be commenced within ten days of the presentation of the final document to the teacher or else the right to appeal shall be deemed waived in all regards; provided, however, that in the case of a TIP appeal, there shall be a second ten day period for a TIP appeal following the end date of the TIP.

D. The Superintendent or the Superintendent's administrative designee shall respond to the appeal with a written answer granting the appeal and directing further administrative action, or denying the appeal. The Superintendent or the Superintendent's administrative designee shall review the evidence underlying the observations of the teacher along with all other evidence submitted by the teacher prior to rendering a decision. Such decision shall be made within fourteen business days of the receipt of the appeal. So long as the decision is made within the timeframe set forth in this paragraph, the decision of the Superintendent or the Superintendent's administrative designee shall be final and binding in all regards and shall not be subject to review at arbitration, before any administrative agency or in any court of law. If the superintendent fails to make a decision within the specified timeframe, the appeal will be sustained.

E. In the event that a tenured teacher receives two or more consecutive ineffective overall APPR rating, the teacher will have the option of requesting an appeal panel prior to the Superintendent's review of the appeal that will consist of two representatives appointed by the EASO President and two administrators appointed by the Superintendent. The panel will review the appeal and provide a recommendation to the Superintendent within a period of no more than 14 daysto determine if there are any outstanding factors that need to be considered by the Superintendent when he conducts his review pursuant to paragraph D above.

F. (1) Notwithstanding the above, in the event that a tenured teacher has received two or more consecutive ineffective overall APPR ratings, the appeal may be, following consultation between the teacher and the association, to an arbitrator selected on a rotating basis. The arbitrator shall make a final and binding decision upon the appeal of the APPR evaluation and/or the TIP, within a period of no more than 30 days. The documentation to be furnished to the arbitrator on behalf of the tenured teacher and by the District shall be exchanged between the tenured teacher and the administration on an immediate basis at the time of submission to the arbitrator. In the event that either party has a question regarding the authenticity of such documentation, the same shall be presented in writing immediately to the arbitrator and copied to the other party for the arbitrator's review and consideration. The Arbitrator shall review the evidence underlying the observations of the teacher along with all other evidence submitted by the teacher prior to rendering a decision. The District and the Association shall split the costs of the arbitrator. (2) In order to take advantage of the procedure outlined in F(l) above, the tenured teacher must consent, following consultation with an Association representative, to the use of an arbitrator from the arbitration panel set forth in paragraph F(l) above. If the tenured teacher is unwilling to do so, the appeal shall be heard by the Superintendent or the Superintendent's administrative designee.

Allevaluators are certified and annually recertified each year by the South Orangetown Central School District Board of Education after each evaluator successfully completes recertification training through Rockland BOCES. The Rockland County BOCES Superintendent and Assistant Superintendent will provide Evaluator Training through the use of video and written teacher lessons using the Danielson Framework for evaluation. A process will be used to increase inter-rater reliablity among all evaluators.
- B. The District will not utilize the peer observation option. The training for all evaluatorswill include the following nine elements:

- (4) the LEA's issuance and/or implementation of the terms of the principal improvement plan, as required under Education Law §3012-d and Subpart 30-3 of the Rules of the Board of Regents.

Appeals Process

- A. A principal who receives an Ineffective rating on their APPR or a rating of Highly Effective on the School Visit Component and Ineffective on the Student Performance Component shall be entitled to appeal their annual APPR rating, based upon a paper submission to the Superintendent's central office administrative designee who has not served as an evaluator of the appellant, who shall be trained in accordance with the requirements of the statute and regulations and also possesses either an SDA or SDL Certification.
- B. The appeal must be brought in writing, specifying the area(s) of concern, but limited to those matters that may be appealed as prescribed in Section 3012-d of the Education Law. Further, a principal who is placed on a Principal Improvement Plan ("PIP") shall have a corresponding right to appeal concerns regarding the PIP in accordance with the requirements set forth in Section 3012-d of the Education Law.
- C. An appeal of an APPR evaluation or a PIP must be commenced within fourteen business days of the presentation of the final document to the principal or else the right to appeal shall be deemed waived in all regards; provided, however, that in the case of a PIP appeal, there shall be a second fourteen business day period for a PIP appeal following the end date of the PIP. This period shall be tolled for any days during said fourteen day period that the principal is on vacation.
- D. The Superintendent's administrative designee shall respond to the appeal with a written answer within 14 days granting the appeal and directing further administrative action, or denying the appeal. If further action is directed, the Superintendent's administrative designee shall review the evidence underlying the observations of the principal along with all other evidence submitted by the principal prior to rendering a decision. Such decision shall be made within fourteen business days of the receipt of the appeal. So long as the decision is made within the timeframe set forth in this paragraph, the decision of the Superintendent's administrative designee shall be final and binding in all regards and shall not be subject to review at arbitration, before any administrative agency or in any court of law. If the designee does not respond within the prescribed timeframe, the appeal will be sustained.
- E. Notwithstanding the above, in the event that a tenured principal has received two or three consecutive Ineffective APPR evaluation ratings, the appeal shall be to an arbitrator, who shall make a final and binding decision upon the appeal of the APPR evaluation and/or the PIP. The documentation to be furnished to the Arbitrator on behalf of the tenured principal and by the District shall be exchanged between the tenured principal and the administration on an immediate basis at the time of submission to the arbitrator. In the event that either party has a question regarding the authenticity of such documentation, the same shall be presented in writing immediately to the arbitrator and copied to the other party for the arbitrator's review and consideration. The Arbitrator shall review the evidence underlying the observations of the principal along with all other evidence submitted by the principal prior to rendering a decision. The Arbitrator's determination of the appeal will be completed within a period of no more than 30 days.

EVALUATOR CERTIFICATION AND RE-CERTIFICATION FOR PRINCIPALS

The process for certification and recertification of all evaluators (lead evaluators, evaluators and independent evaluators) of principals is outlined below. The superintendent and other district administrators will receive certification training and re-certification training annually as outlined below. The district administrators will be trained in and certified to be both Lead Evaluators and Independent Evaluators of principals.

- A. The superintendent, and/or his or her designee, will receive lead evaluator certification and re-certification by completing lead evaluator certification training for principals through Rockland BOCES each year.
- B. The lead evaluator certification for all District administrators that will take place annually. This training program will occur annually in order to certify and recertifyall evaluators for principals. The District will not utilize the peer observation option. The evaluator certification for district administrators will include the following nine elements: (1) The Leadership Standards and their related functions, as applicable; (2) Evidence-based observation techniques that are grounded in research; (3)Application and use of any methodology as part of an SLO and any optional second measures of student performance used by the LEA to evaluate its principals; (4) Application and use of the State-approved principal rubric(s) selected by the LEA for use in evaluations, including training on the effective application of such rubrics to observe a principal's practice; (5) Application and use of any assessment tools that the LEA utilizes to evaluate its building principals; (6) Application and use of any locally selected measures of student growth used in the Optional subcomponent of the Student Performance category used by the LEA to evaluate its principals; (7) Use of the Statewide Instructional Reporting System; (8) The scoring methodology utilized by the Department and/or the LEA to evaluate a principal under this Subpart, including the weightings of each subcomponent within a category; how overall scores/ratings are generated for each subcomponent and category and application and use of the evaluation matrix(es) prescribed by the Commissioner for the four designated rating categories used for the principal's overall rating and their category ratings; (9)Specific considerations in evaluating principals of English language learners and students with disabilities
- C. The superintendent, or his or her designee, will arrangea training program, through Rockland BOCES, for all other evaluators.
- D. In addition to the elements above, the certification of all evaluators for principals will include the following elements: (1) Review and practice on inter-rater reliability of observations through video analysis and other methods to calibrate the accuracy of observation scores and ratings; (2) Comparison of observations and evaluations, to detect disparities on the part of one or more evaluators; (3) Annual data analysis of scores and evidence in observations and evaluation to further calibrate observations.
- E. All evaluatorswill receive certification and re-certification training annually over two days, totaling six hours, through Rockland BOCES.
- F. The superintendent will review all observation and evaluation reports conducted by evaluators of principals. This process will be used to ensure inter-rater reliability. Additional data will be analyzed using the electronic teacher evaluation management system. Feedback on the quality of reports will be given to all evaluators during the certification and re-certification program.

APPENDIX B

PRINCIPAL IMPROVEMENT PLAN

- 1. Upon receiving a rating of "Developing" or "Ineffective", a principal shall be provided with a Principal Improvement Plan ("PIP"). The PIP shall be provided by no later than October 1st or as soon thereafter as is practicable. The parties understand and agree that the sole and exclusive purpose of a PIP is the improvement of principal performance and that the issuance of a PIP is not a disciplinary action. The PIP shall be developed in consultation with the principal. The Association President shall be informed of the District's intent to provide a PIP to an administrator within ten (10) days of the principal's "Developing" or "Ineffective" rating. Whenever a principal is placed on a PIP and with the agreement of the principal, the Association President shall be provided with a copy of the PIP.
- 2. A PIP shall clearly specify: (i) the area(s) in need of improvement; (ii) the time limit for achieving improvement, that shall range between three (3) months and a semester; (iii) how improvement will be measured and monitored, and provide for periodic reviews of progress and goal achievement; and (iv) the appropriate differentiated professional development opportunities, materials, resources and supports the District will make available to assist the principal.
- 3. The length of a PIP for a probationary principal shall be three (3) to five (5) months in duration, as determined by the District. The length of a PIP shall be not less than five (5) months in duration for a tenured principal, as determined by the District.
- 4. In the event that coursework is recommended for the administrator, any tuition costs or registration fees shall be borne by the District in their entirety. No disciplinary action predicated upon ineffective performance shall be taken by the District against a principal until a PIP has been fully implemented. However, nothing herein shall prevent the District from introducing into evidence an evaluation or a PIP in a subsequent disciplinary action.
