#### **Equitable Services Under ESSA: Fiscal and Programmatic Responsibilities**


To discuss the LEA's responsibilities under the Every Student Succeeds Act (Section 8501 of ESSA) regarding the provision of equitable services to private schools.

Programs that apply include:

- Title I Part A Improving Basic Programs Operated by LEAs
- Title II Part A Supporting Effective Instruction Grants
- Title III Part A English Language Acquisition, Language Enhancement, and Academic Achievement
- Title IV Part A Student Support and Academic Enrichment Grants
- Title IV Part B 21st Century Community Learning Centers (this is a competitive grant opportunity)



## **Continuous Cycle of Consultation with Private Schools**





New York State EDUCATION DEPARTMENT

#### **LEA Responsibility Under the Law**

LEA maintains *fiscal* and *programmatic* control of services provided at private schools under all ESSA-funded programs.

## ESSA 8501(d)



#### **Service Delivery and Payment Methods:**

- Contract with third-party provider (e.g. tutoring service, PD) provider)
- Deploy LEA staff (e.g. reading teachers, instructional coaches)
- Reimburse another LEA for providing services (applies for Title I services to resident students attending private schools located outside the LEA's district)



## **TRUE OR FALSE?**

The LEA can reimburse a private school for allowable conference and travel fees paid on the school's credit card once the private school provides the LEA with receipts and conference brochures/materials.



#### FALSE

LEA can never make payment directly to a private school or reimburse a private school directly for services.



## **TRUE OR FALSE?**

The LEA can pay teachers employed by the private school to provide services to eligible students at that school.



## TRUE

However, only if the selected teachers contract with the LEA and provide the services outside of their regular, salaried hours.



Delivery of services to private schools should begin in a comparable timeframe to when they begin in the public schools.

## The LEA is required to:

- ✓ Determine if services are allowable, necessary, and reasonable under the Title.
- Engage in and document ongoing consultation to monitor the implementation of the services.
- Conduct and document evaluation of the services.



## **Programmatic Control of Services**

## **TRUE OR FALSE?**

If the LEA's Title I program is designed to provide supplementary reading supports at the K-5 level, the LEA must provide the same type of program at private schools.



## **Programmatic Control of Services**

## FALSE

Services to private schools do not have to be the same as those delivered to public schools (equitable not equal). The services should be based on the needs of the students enrolled in private schools, which should be discussed during consultation.



## **Obligation of Funds**

Funds allocated to a local educational agency for educational services and other benefits to eligible private school children shall be obligated in the fiscal year for which the funds are received by the agency.

## ESSA Section 8501 (a)(4)(B)



## Carryover

If funds earmarked for equitable services are not obligated by the end of the program period (8/31), the LEA may carry over these funds into 2020-21. The LEA can file and FS-10A (Amendment) after it has:

- 1. Received approval for the 2020-21 budgets through the Consolidated Application
- 2. Completed an FS-10F (Final Expenditure Report) for 2019-20 budgets
- 3. Received notice that Grants Finance has confirmed the amount of carryover funds available
- **Title IA:** Funds earmarked for private schools must stay within the private school allotment.
- **Title IIA, IVA, and IIIA:** Funds earmarked for private schools may be carried over for those specific private schools if there are extenuating circumstances that prevented the LEA from obligating those funds. If there are no extenuating circumstances, leftover funds may returned to the general pool for recalculation of public and private school shares.
