The assessments being used for any Student Learning Objective are aligned to the appropriate content-area standards and New York State Common Core Learning Standards.

The assessments for Career and Technical Education programs were developed through a collaborative project with other BOCES, in which item banks were developed and vetted through multiple years of testing. The item banks are secure and the program Director is responsible for developing the assessment from the item banks and for maintaining the securing and integrity of the item banks. Pre and post-assessments are administered in each course. Teachers of record are prohibited from scoring their own students' assessments. Practitioners with appropriate knowledge and experience score the assessments and submit the scores to the program administrators.

The ELA, Math, Science and Social Studies assessments, as well as alternate assessments were locally-developed through collaboration of content-area experts and instructional specialists. The design of these assessments are modeled after New Your State assessments in the corresponding content areas. Pre and post-assessments are administered in each course. Teachers of record are prohibited from scoring their own students' assessments. Content-area experts and instructional specialists score the assessments and submit the scores to the program administrators.

The classroom teacher will use relevant baseline data gathered through pre-assessments, as appropriate, or through the analysis of historical data provided by the home district to determine individual targets for each student. The percentage of students meeting their individual target will be determined and the percentage will be converted to a HEDI rating using the state-provided chart.
