

Our Challenge: Graduating All Students College and Career Ready

New York's 4-year high school graduation rate is 73.4% for All Students However, the gaps are disturbing.





3-Year Associate Graduation Rate At Initial Institution




College Instructors and Employers Say Graduates Are Not Prepared for College and Work

Average estimated proportions of recent high school graduates who are not prepared






The more remedial classes a student takes, the less likely they are to stay in college



Strengthen Connections Between Higher Ed. the State's Social and Economic Structure

- Identify realistic job opportunities for graduates
- Enhance communication and relationships with business and industry, and government to identify core skills and provide workplace opportunities and internships
- Strengthen partnerships with business, labor and other community organizations to publicize higher education opportunities and the connection to career opportunities
- Increase affordability by reducing costs without sacrificing the quality of education

The Importance of Affordability in Higher Education


- New York ranks 2nd in grant aid per student; 11th in percent of low-income students in college
- In 2011, SUNY (\$6,750) and CUNY (\$5,250) 4-yr average undergraduate tuition & fees were below national average.
- However, TAP has not kept pace with the cost of tuition.

Average Loan* per Full-time First-time Student Loan Recipients At 4 Year Institutions: 2009-10



These data do not include private loans taken by students or parents and not reported to student aid offices, which are significant. A 2011 Federal Reserve Bank of NY report found that the amount of student loans nationally will surpass the \$100 billion mark and the outstanding balance will exceed \$1 trillion.

College Readiness and Affordability



- College- and career-readiness includes having the tools to understand:
 - > Total costs of college
 - Expected loan debt and payment terms
 - Employment options and projected income for a course of study
 - The Regents Priorities for the Statewide Plan for Higher Education focus on what students and families need to know before they choose how much to owe

According to the College Board, students are borrowing twice what they did a decade ago after adjusting for inflation.

Ensuring Access to Higher Education

Liberty Partnerships Program (LPP)

High School graduation rates are improved for the most at-risk students

Science and Technology Entry Program (STEP)

Students are more likely to enter college and take STEM courses

Higher Education Opportunity Program (HEOP)

HEOP students graduate college at higher rates

Collegiate Science and Technology Entry Program (CSTEP)

CSTEP graduates pursue graduate programs and professional licensure

 - Too many New Yorkers are denied the higher education opportunities they need to fully contribute to our economy




Support for Early College High Schools (ECHS)

TAP for Early College High School Students (S.5647 – Flanagan)


- More than 30 ECHS sites in New York serve over 9,000 traditionally underrepresented students
- ECHS students gain a head start on college and are more likely to graduate on time.
- Smart Scholars programs are designed to graduate students with at least 20 college credits.

Demographics of ECHS Students




Closing the achievement gap while preparing more students for college and career

Clinically-based Teacher Preparation Pilots



- 11 awards distributed
- Institutions of higher education partner with high-need P-12 schools
- Over 400 teaching candidates will be prepared

- Provide richer clinical component than traditional teacher preparation programs
- Effectively prepare teachers for high-need schools using RTTT funding
- Increase retention of those teachers to positively impact student growth and achievement

Fact Sheet on NY Proprietary Schools

The scale of our responsibility vs. our capacity:

- More than 200,000 students
- Approximately 500 licensed schools with an additional 125 schools awaiting licensure – collecting between \$600 and \$750 million annually in tuition
- 21 Department staff with an operating budget of approximately \$3 million.

Enhanced Information & Protection for Students in Proprietary Schools*

The Regents legislative proposal (S.4268-C LaValle / A.7859-A Glick) will:

Increase Student Protection

- Support the most comprehensive oversight in the nation
- Provide resources to respond to this expanding higher education sector
- Work with schools in financial distress, prevent closures and protect the Tuition Reimbursement Account, and make certain expenses eligible for reimbursement when a school closes
- Assist students when schools close engage a "teach out" school more quickly

Inform Consumers

- Provide schools on-line access to application processing and approvals
- Provide consumers on-line access to school status, teacher licensing, and curriculum approval to assist in making a sound educational decision

Enhance Oversight Capacity

- Update 25 year-old computer system to provide better monitoring
- Permit enhanced financial reviews and expand use of investigative tools
- Establish candidate schools, allowing them to operate while coming into compliance

- Licensing is inextricably linked to NYS education
- The professions are at the core of the state's economy
- Licensees must be qualified and competent to provide health, design, and business services - Professional practice affects every citizen in NYS

Enhanced and Modernized Customer Service

- Expanded communications with licensees and the public:
 - Respond to 1,000,000 + emails and telephone calls annually
 - More than 1,000 Frequently Asked Questions and Answers on the Web
- Use of on-line registration renewals is growing
- Implementing scanning system to replace paper files (1.3 million each year) with electronic files
- Replacement of antiquated licensure and discipline computer system included in statewide E-licensing project





Implementation of Critical New Laws and Initiatives

A number of significant new laws impacting the Professions were enacted in 2011 which:

- Authorize practice for Polysomnographic Technologists (Chapter 262 Hoyt/Grisanti) and Occupational Therapy Assistants (Chapter 460 Canestrari/LaValle)
- Require Master's Degree or higher for Physical Therapy licensure (Chapter 410 Canestrari/Oppenheimer)
- Allow Collaborative Management of Drug Therapy by pharmacists in certain health care facilities (Chapter 21 Canestrari/LaValle)
- Create Design Professional Corporations (Chapter 550 Canestrari/LaValle)
- Permit CPA Mobility (Chapter 456 LaValle/Glick)
- Extend deadline for Corporate Practice Waiver for non-profit mental health entities (Chapter 187 Glick/Johnson)
- Create Corporate Practice Waiver for 4410/Early Intervention providers (Chapter 581 Glick/Flanagan)
