## COVID TESTING REQUIREMENTS BY ZONE

#### RED ZONE

15% OF TOTAL STUDENT/STAFF IN-PERSON POPULATION TESTED EVERY 2 WEEKS

TOTAL OF 30% OVER ONE MONTH

IF THE RANDOM SAMPLING GENERATES 9 OR MORE POSITIVE CASES IN ANY SCHOOL, OR IF FOR A SAMPLE SIZE OF MORE THAN 300 WEEKLY TESTS, ACHIEVES A POSITIVITY RATE OF 2% OR HIGHER (6 CASES OR MORE DEPENDING ON SAMPLE SIZE) IN NEW YORK CITY, OR 3% (9 OR MORE CASES DEPENDING ON SAMPLE SIZE) OUTSIDE OF NEW YORK CITY, OF ONE SUCH DISCRETE SAMPLE, THEN THE SCHOOL WILL BE REQUIRED TO CLOSE.

#### ORANGE ZONE

10% OF TOTAL STUDENT/STAFF IN PERSON POPULATION TESTED EVERY 2 WEEKS

TOTAL OF 20% OVER ONE MONTH

IF THE RANDOM SAMPLING GENERATES 9 OR MORE POSITIVE CASES IN ANY SCHOOL, OR IF FOR A SAMPLE SIZE OF MORE THAN 300 WEEKLY TESTS, ACHIEVES A POSITIVITY RATE OF 2% OR HIGHER (6 CASES OR MORE DEPENDING ON SAMPLE SIZE) IN NEW YORK CITY, OR 3% (9 OR MORE CASES DEPENDING ON SAMPLE SIZE) OUTSIDE OF NEW YORK CITY, OF ONE SUCH DISCRETE SAMPLE, THEN THE SCHOOL WILL BE REQUIRED TO CLOSE.

#### YELLOW ZONE

SCHOOLS IN YELLOW ZONES MUST TEST 20% OF INPERSON STUDENTS/STAFF OVER THE TWO-WEEK
PERIOD IMMEDIATELY FOLLOWING THE
ANNOUNCEMENT OF A YELLOW ZONE
DESIGNATION. IF THE RESULTS OF THE TESTING
REVEAL THAT THE POSITIVITY RATE AMONG THE 20%
OF THOSE TESTED IS LOWER THAN THE YELLOW
ZONE'S CURRENT 7-DAY POSITIVITY RATE, TESTING
AT THAT SCHOOL WILL NO LONGER BE REQUIRED
TO CONTINUE. THE CURRENT POSITIVITY RATE FOR

## COVID-19 TESTING IN SCHOOLS

- SCHOOLS CAN CONTRACT WITH A LABORATORY OR HEALTHCARE FACILITY TO CONDUCT COVID-19 TESTING OF STUDENTS AND STAFF MEMBERS ATTENDING/TEACHING IN PERSON.
- SCHOOLS MUST HAVE THE WRITTEN CONSENT OF PARENTS/GUARDIANS TO CONDUCT TESTS ON STUDENTS AT SCHOOL, OR FOR A CONTRACTOR TO DO SO.
- SCHOOLS DOING THEIR OWN TESTING MUST HAVE A LIMITED LABORATORY CERTIFICATE, AND APPROPRIATE PPE REQUIRED FOR SCHOOL HEALTH PERSONNEL CONDUCTING COVID-19 TESTS, AND STAFF ARE TRAINED TO CONDUCT SUCH TESTS.

## **COVID-19 VACCINES**

- ELIGIBLE PERSONS MUST COMPLETE THE REQUIRED FORM: HTTPS://FORMS.NY.GOV/S3/VACCINE
- BRING PROOF OF ELIGIBILITY TO YOUR APPOINTMENT. WHEN YOU GO TO YOUR VACCINATION SITE FOR YOUR APPOINTMENT, YOU MUST BRING PROOF OF ELIGIBILITY. THIS MAY INCLUDE AN EMPLOYEE ID CARD, A LETTER FROM AN EMPLOYER OR AFFILIATED ORGANIZATION, OR A PAY STUB, DEPENDING ON THE SPECIFIC PRIORITY STATUS. IF YOU ARE ELIGIBLE DUE TO AGE, YOU SHOULD BRING A FORM OF ID (LIKE A DRIVER'S LICENSE OR PASSPORT) THAT INCLUDES YOUR DATE OF BIRTH. YOU WILL NEED TO COMPLETE A CLINICAL QUESTIONNAIRE FORM AT THE TIME OF YOUR APPOINTMENT.
- APPOINTMENTS FOR SECOND DOSES WILL BE MADE AT THE TIME OF THE FIRST APPOINTMENT.

### VACCINE CONSIDERATIONS

- MODERNA VACCINE: APPROVED FOR AGES 18 +. THAW THE VIALS FOR 2.5 HOURS IN A REFRIGERATOR SET BETWEEN 36 AND 46 DEGREES. THEN REST THEM AT ROOM TEMPERATURE FOR 15 MINUTES. DO NOT REFREEZE. SWIRL GENTLY BETWEEN EACH WITHDRAWAL. DO NOT SHAKE. INSPECT EACH VIAL FOR PARTICULATE MATTER OR DISCOLORATION. AND THEN THERE'S THIS: ONCE OPEN, A VIAL IS GOOD FOR ONLY SIX HOURS. THE SECOND DOSE IS GIVEN 28 DAYS AFTER THE FIRST. MODERNA COVID-19 VACCINE INFORMATION | CDC
- **PFIZER-BIONTECH'S VACCINE**: APPROVED FOR AGES 16+. MUST BE STORED IN SPECIALIZED FREEZERS AT 94 DEGREES BELOW ZERO. ONCE OUT OF THAT FREEZER IT MAY BE STORED ONLY 5 DAYS IN A REFRIGERATOR BETWEEN 35-46 DEGREES. VACCINE MUST BE DILUTED. ONCE THE VIAL IS OPEN IT IS GOOD FOR ONLY SIX HOURS. THE SECOND DOSE IS GIVEN 21 DAYS AFTER THE FIRST DOSE. PFIZER-BIONTECH COVID-19 VACCINE INFORMATION | CDC
