## OFFICE OF TEACHING INITIATIVES

- The new edTPA passing scores for candidates who receive their edTPA score after January 1, 2018 are available on the <u>OTI website</u>. Candidates who submit their edTPA on December 8, 2017 or later will <u>receive their</u> <u>score after January 1, 2018</u> when the new passing scores apply.
- A proposed regulation <u>amendment</u> would make the edTPA safety net available until June 30, 2018. Beginning on July 1, 2018, the ATS-W (the current edTPA Safety Net) will no longer be available and candidates will no longer be able to register for or take that exam.
- The edTPA Multiple Measures Review Process (MMRP) will be available in the spring to candidates who receive their scores after January 1, 2018 and do not pass the edTPA, but score within two points of the edTPA passing score and satisfy additional criteria.

### **OFFICE OF COLLEGE AND UNIVERSITY EVALUATION**

**Partnership Agreement Between CAEP and NYSED**. OHE and the CAEP Work Group composed of 10 higher education deans and administrators met in September to review the second round of feedback from CAEP. OHE sent an updated draft to CAEP and received a third round of feedback from them in early October. The CAEP Work Group and OHE will be meeting to discuss the feedback. The three rounds of feedback are moving the draft agreement closer to a final version.

#### **OFFICE OF HIGHER EDUCATION ACTIVITIES**

**PSEL Listening Tour.** The <u>Principal Preparation Project Advisory Team</u> identified 11 recommendations for the Board of Regents, including adopting the <u>Professional</u> <u>Standards for Educational Leaders (PSEL)</u>. The <u>proposed regulation amendments</u> related to the PSEL are currently out for public comment and may be voted on at the December Board of Regents meeting. To gather stakeholder feedback for the Regents, OHE is conducting a listening tour with stops in Albany, Bronx, Brooklyn, Buffalo, Manhattan, Rochester, and Syracuse. **NYSATE/NYACTE Conference.** The following OHE staff participated in the NYSATE/NYACTE Pre-Conference (October 18) and Conference (October 19-20) to provide information about OHE activities, answer questions, and engage in a dialogue about important issues in higher education.

- John D'Agati, Deputy Commissioner, engaged in a conversation with conference participants during a pre-conference plenary meeting and continued the conversation with Education Deans and Directors.
- Laura Glass, Coordinator of Education Programs, provided an overview of the NYS edTPA Handbook Review Process in two pre-conference sessions and discussed the Clinical Practice Work Group activities during the conference Panel on Clinical Practice.

## **OFFICE OF HIGHER EDUCATION COMMITTEES**

**Clinical Practice Work Group.** The Clinical Practice Work Group will examine the <u>regulations related to field experiences and student teaching</u> in teacher

preparation programs. The work group has been convened in response to one of the <u>edTPA Task Force recommendations</u>. The work group has met four times and will meet once a month through this fall. The members are divided into three subcommittees to develop recommendations related to their topic: candidate support, experiences prior to student

teaching, and student teaching. <u>The work group webpage</u> shows the charge, meeting dates, agendas, minutes, and membership.

**DASA (Dignity for All Students Act) Task Force**. The DASA Task Force has been reconvened to examine the length of the <u>DASA training</u> for candidates. The reconvened task force has met four times and will meet once a month through this fall. There has been some discussion of requiring educator preparation programs to offer a three-credit multicultural education course to ensure that future educators are prepared to work with a diverse student body. <u>The task force webpage</u> shows the charge, meeting dates, agendas, minutes, and membership.

#### NEW YORK STATE TEACHER CERTIFICATION EXAMINATIONS (NYSTCE) TEST DEVELOPMENT ACTIVITIES

**edTPA Handbook Review Process.** Representatives from OHE, New York State higher education, and the Stanford Center for Assessment, Learning, and Equity (SCALE) are collaborating on the development of an edTPA Handbook Review Process in response to one of the recommendations from the edTPA Task Force. This process will enable the New York State higher education community to systemically provide feedback to SCALE on the edTPA handbooks. One step in the process is collecting from faculty, staff, and administrators in New York State educator preparation programs recommendations for specific changes to the edTPA handbooks based on evidence of a systemic issue or misalignment with pedagogy and practice through a survey. The deadline for completing the New York State <u>edTPA Handbook Review Survey</u> has been extended to October 23, 2017. Following the collection of these recommendations, a panel of higher education representatives will review the results, determine if there is consensus regarding particular recommendations for a handbook area, and forward such recommendations to SCALE via NYSED. SCALE will review the recommendations from New York and other states and then consider any possible updates to the handbooks.

**Revised Multi-Subject: Secondary Teacher Mathematics Test Framework.** In response to feedback from the field, a committee of P-12 educators, higher education faculty, and other NYS stakeholders redeveloped Part Two (Math) of the Multi-Subject: Secondary Teachers Grades 7-12 Content Specialty Test (MST 7-12) for candidates pursuing the Students with Disabilities Grades 7-12 Generalist certificate. The revised Part Two (Math) will be operational in fall of 2018. The revised framework is posted on the <u>NYSTCE website</u> so that educator preparation programs can refer to it for curriculum planning purposes and candidates who plan on taking the test in the fall of 2018 or later can use it along with the upcoming new preparation materials for the test. <u>A memo to the field</u> provides additional details about the revised Part Two (Math) of the MST 7-12.
