BOARD OF REGENTS OCTOBER ITEMS

Student Data Privacy and Security. Education Law Section 2-d outlines certain requirements for educational agencies and their third-party contractors to ensure the security and privacy of personally identifiable information (PII) of students. The Department proposed regulatory amendments to add Part 121 to the Commissioner's Regulations to implement this law. Provisions in the proposal include clarifying the data privacy and security obligations of educational agencies and third-party contractors as well as directing educational agencies to ensure that all employees who handle PII receive annual data security and privacy training. The proposal went out for public comment twice. In response to the most recent comment period, the Department presented changes to the proposal to the Board of Regents. The proposed regulatory amendments have moved to another 45-day public comment period that ends on December 9, 2019.

ASSESSMENT VOUCHERS

Education Deans/Directors are currently providing the Office of Teaching Initiatives with the data needed to distribute assessment fee vouchers for the Content Specialty Tests (CSTs), Educating All Students (EAS) test, and edTPA. In order to distribute the vouchers, the office needs data from the institutions of higher education as soon as possible.

NYSATE/NYACTE CONFERENCE PRESENTATIONS

The 2019 <u>New York State Association of Teacher Educators</u> (NYSATE)/New York Association of Colleges for Teacher Education (NYACTE) Annual Fall Conference took place on October 16-18 in Saratoga Springs and included <u>presentations</u> from New York State Education Department leaders and staff members. From the Office of Higher Education, Assistant Commissioner Anael Alston and Laura Glass each led plenary sessions, and Patrick Darfler-Sweeney participated in a roundtable Session. Eric Sweet, Susan Brockley, Andrea Faoro (Office of Curriculum & Instruction) and Tanya Amodio-Kovacs (Office of Bilingual Education and World Languages) also led sessions. John D'Agati, former Deputy Commissioner for the Office of Higher Education, was presented with the NYSATE-NYACTE Award for Service to the Field of Teacher Education.

DRAFT NYS K-12 COMPUTER SCIENCE AND DIGITAL FLUENCY LEARNING STANDARDS

The New York State Education Department (NYSED) has released a draft of the NYS K-12 Computer Science and Digital Fluency Learning Standards for stakeholder feedback. The draft standards were developed and reviewed by committees consisting of NYS educators, parents, curriculum specialists, school administrators, and institution of higher education faculty. NEW YORK STATE TEACHER CERTIFICATION EXAMINATIONS (NYSTCE) TEST DEVELOPMENT ACTIVITIES

Candidate Field Testing Opportunities. Juniors, seniors, or graduate students currently or recently enrolled in an approved educational preparation program preparing them for New York State Initial certification can <u>participate in a field test</u> for the redeveloped Content Specialty Tests (CSTs) in the following subject areas through November 22, 2019: English Language Arts, Health, Mathematics, Physical Education, and Social Studies. By participating in a field test, candidates preview actual test questions, gain valuable practice in computer-based testing, and provide input on future tests. In addition, they receive a \$50 Barnes & Noble eGift card OR a \$100 test fee voucher that may be applied to future test fees. Ongoing field test opportunities can be found in the "Important Announcements" section of the <u>NYSTCE website</u>.

Recruiting Educators for Test Development Committees. The Department is seeking educators to participate in the following committees that will meet in early 2020. Revised Science Content Specialty Tests (CSTs). It is anticipated that the revised CSTs in Biology, Chemistry, Earth Science, and Physics will become operational on November 11, 2019. The Board of Regents <u>adopted regulatory amendments</u> to create safety nets for the CSTs in Biology, Chemistry, Earth Science, and Physics so that candidates may take either the revised CST or the predecessor CST for one year after the revised CSTs in each science subject area becomes operational. The test frameworks are available on the <u>NYSTCE website</u> to assist candidates and teacher preparation programs in the preparation of candidates for the revised tests. Study Guides for the revised CSTs in <u>Biology</u>, <u>Chemistry</u>, <u>Earth Science</u>, and <u>Physics</u> are also available on the <u>NYSTCE website</u>. The study guides include sample selected-response questions and sample constructed-response items.

EDTPA PASSING SCORE INCREASING

In June 2017, the edTPA Standard Setting Panel recommended new passing scores for the edTPA and a four-year phasein period for the new passing scores. The phase-in period began on January 1, 2018. According to the schedule, the edTPA passing scores will increase by one point on January 1, 2020.

Candidates who submit their edTPA after December 5, 2019 will <u>receive their score after January 1, 2020</u> when the new passing scores apply. The passing scores will then increase by one point for the last time on January 1, 2022. The passing scores effective January 1, 2020 and January 1, 2022 are posted on the <u>Office of Teaching Initiatives website</u>.
