- 1. FAQ List: I have compiled many frequently asked questions together on a <u>uniform list</u> on the NYSED Business Education home page. These reflect various questions that may come up in business education programs. This page will be updated when/if any information changes. If you have a frequently asked question that you feel should be posted, please contact me.
- **2. Listserv:** I have re-launched the business education listserv. If you have any new colleagues, please encourage them to join the Listserv to stay up to date on NYSED newsletters, jobs, and other pertinent information. My goal is to put out a newsletter at least once per month during the academic year.
- **3. Middle Level:** As of the 2018-19 school year, business teachers may now teach the middle level CTE requirement. Please note that if you are only certified in business, you may only teach business content at the middle level. The middle level content is broken up into six overarching theme modules that have been interpreted by business teachers as four content modules. These should be used as a model when determining what to teach at the middle level.
- **4. Office/SED Changes:** We have a new director of Career Readiness and Workforce Partnerships, Amy Cox. Amy comes to us from supporting the NYS P-TECH programs at NYSED. We are glad to have her on board. Phil Dettelis (technology associate) has left to pursue another opportunity and Cheryl Winstel will be retiring in October. We ask for your patience as other staff, including myself, will be taking on additional responsibilities until these positions are filled.
- **5. Graduation Requirements:** A blue-ribbon commission is being formed by the Board of Regents to examine current graduation requirements and whether or not they are meeting the needs of New York's students.
