This notice is to inform you that on June 25, 2014, the New York State Board of Regents received an application to establish Tuxedo STEM Academy at George F. Baker High School Conversion Charter School, a charter school in the Tuxedo Union Free School District. The charter school was approved by the Tuxedo Board of Education, and was reviewed for possible action at the January 12, 2015 meeting of the Board of Regents. On that date, the Board of Regents voted to return the initial application to establish the charter school to the Tuxedo BOE for reconsideration, and with the following comment: The proposed charter does not adequately address the fiscal and programmatic impact on surrounding school districts.

Thereafter, the Tuxedo BOE approved a revised application, which was submitted to the New York State Board of Regents on February 20, 2015. The revised application for this school is being reviewed for possible action at the March 16-17, 2015 meeting of the Board of Regents.
