DescriptionRegentsItem:	The school is seeking a revision to their approved charter. Instead of serving 455 students in grades 5-8 they are seeking to serve 375 students in grades 6-8. In year one of operation, 2015-16, the school proposes to enroll 125 sixth grade students; with 250 students in grades 6 and 7 in year two and 375 grade 6-8 students in years three through five of the approved charter. Overall, the school seeks to serve one less grade level and 80 fewer students.

The application for this school is being reviewed for possible action at an upcoming Board of Regents meeting.

Please note that pursuant to Education Law section 2857(1) and 8 NYCRR 119.4 (available at <http://www.p12.nysed.gov/psc/law.html>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing revision. This hearing, which is required to be held within the community that is potentially impacted by the charter school, must be held within 30 days of your receipt of this letter.

Please provide the following required documentation:

- A copy of the public hearing notice must be provided to the Charter School Office at the time of dissemination
- Written confirmation that this hearing was held must be sent to the Charter School Office no later than the next business day following the hearing.
- Copies of any and all written records or comments generated from this hearing must be sent to the Charter School Office within 15 business days after the hearing.

In addition, the Board of Regents welcomes your comments on the proposed charter school revision, including those related to the programmatic and fiscal impact of the proposed revision or other public and non-public schools in the area.
