#### **Emergency Conditional Clearances**



# SCHOOL OVERVIEW

Capital Preparatory Bronx Charter School (CP Bronx) is the second school in the portfolio of the Capital Preparatory Schools (CPS) network to open its doors in New York City. CPS has developed a life-changing educational model providing scholars with a college prep, social justice, and an academic experience that prepares them to be agents of change equipped with critical college and career readiness skills.

CP Bronx began its mission to provide college preparatory educational experiences for all scholars in District 11 during a pandemic for the 2020-2021 school year. Capital Prep opened its doors to 194 sixth and seventh grade scholars this first year and was fully enrolled in our second year for grades six to eight for the 2021-2022 school year, with a five hundred scholar waitlist. We concluded our year with 238 scholars. We are fully enrolled for our 2022-2023 school year with 402 scholars for grades six to nine.

Our returning and new scholars are excited and anxious to return to our school building with High School scholars for the first time. Our young school is growing and impacting the community in positive ways, as we continue the legacy of ensuring scholars from the community gain acceptance to 4 year colleges and universities. CP Bronx, like all CPS schools, offers scholars support through two "houses," one focused on academics and the other focused on "affective" the social and emotional support. The model combines college prep classes and an early college high school experience with a strong advisory program designed to strengthen the relationship between the scholars and their learning environment. Many scholars grow from being significantly behind grade level when they first enroll to taking at least one college course by the end of their junior year. This transformative academic progress is facilitated by a caring Scholar Assistance Team (SAT) focused on identifying each scholar's challenges and helping to develop a support plan to address each one. The Capital Prep learner expectations (Collaborator, Problem Solver, Researcher, Empathetic Citizen, and Pillar of Knowledge) are utilized in both the academic and affective setting to help both Illuminators (our title for our teachers) and scholars meet their goals.

Due to the pandemic our inaugural school year started off remotely and our second year of operation presented challenges working through the Covid fallout. During the distance learning experience, it was a priority for the school to establish clear communications and expectations regarding scholar attendance and engagement. Our scholars were committed to coming to school as demonstrated through an averaged 97% daily attendance rate. We also established a culture of care, emphasizing relationship building and leveraging our connection which supports in times of correction. As we started to gather data on scholars using internal and external formative and summative assessments, we used the data to drive our instruction. Using online platforms to deliver the assessments supported illuminators with a quick turnaround time for feedback. This timely turnkey of data kept families and scholars informed of their academic performance. Having

experienced our first full year as a middle school in the building our school has exhibited a strong community and culture rooted around academic performance and affective support.

# GOAL 1: ENGLISH LANGUAGE ARTS

# Goal 1: English Language Arts

Each year, 75 percent of all tested scholars in at least their second year will perform at or above proficiency on the New York State English Language Arts examination for grades 6-8. In addition to meeting all requirements for the New York State Regents pass rates for graduation.

#### BACKGROUND

During the 2022-2023 school year the English Language Arts Department will adapt the 6th through 8th grade curriculum by Lavinia Group, while providing in-person instruction. Lavinia's curriculum will aid in the development of reading and writing skills due to their unique curriculum that blends reading and writing lessons through novel study and close reading techniques. Daily lessons include objectives aligned to ELA Common Core Standards for scholars to receive daily instruction and practice to support their proficiency of grade level standards. ELA Illuminators prepare purposeful lessons that include modeling reading and writing techniques, focused scholar independent reading and writing tasks, and ensure to provide feedback to scholars for scholars to understand their level of performance. Academic talk is key to developing a culture of joyful learning. Our goal is to improve scholar comprehension and speaking skills by engaging in fruitful discussions about the texts we encounter.

One fundamental change to this year's instruction is the implementation of RTI Instruction on Fridays. During the week, illuminators are intentionally collecting data from scholars' classwork to determine their proficiency level on a standard that was practiced and assessed throughout the

week. RTI will provide scholars with enrichment, a re-teach lesson, and an opportunity to work on skills that have not been mastered. Once targeted, standard- based lessons and practice is provided to scholars they will be reassessed.

Another fundamental change for supporting our scholars' ELA skills development has been the implementation of Reading Plus and target small group guided reading. Reading Plus, a digital reading intervention program, is employed for scholars to practice their reading, fluency and vocabulary. We are insistent that each scholar should be on grade level or two grade levels above for reading skills and Reading Plus will assist scholars in meeting this goal. At the end of Quint 3 (out of 5), an initial adaptive diagnostic assessment was administered to inform all stakeholders of each scholars' reading proficiency. Reading Plus created automated customized lessons aimed to develop skills and stamina to build independent reading skills. For this program, as scholars display mastery they receive increasingly higher levels of practice and rigor. Scholars and illuminators are equally responsible for the knowledge of their grade level reading performance and the needed steps to be on grade level or 2 grade levels above by end of each school year. During Quint 4 and Quint 5 scholars complete sixty minutes on a weekly basis to complete their individualized reading lessons and progress in their reading level.

The instruction of ELA illuminators is observed weekly to guarantee quality instruction is provided to scholars. After observations, meetings are held to discuss delivery of instruction and curriculum, review scholar work, and name next steps to meet scholar needs. Meetings are also conducted with the Dean of Academics and the Director of ELA to collaborate on observations of the ELA team, review scholar data, discuss the implementation of guided reading, establish school-wide next steps, and plan for future professional developments. Additionally, illuminators receive professional development weekly from their Director of ELA and from their Dean of Academics to assure we are working towards goals, developing skills, reviewing data and collaborating on lesson planning.

#### ELEMENTARY AND MIDDLE ENGLISH LANGUAGE ARTS

#### Goal 1: Absolute Measure

Each year, 75 percent of all tested students enrolled in at least their second year will perform at or above proficiency on the New York State English language arts examination for grades 3-8.

#### METHOD

The school administered the New York State Testing Program English Language Arts ("ELA") assessment to students in 6th through 8th grades in spring 2022. Each student's raw score has been converted to a grade-specific scaled score and a performance level.

The table below summarizes participation information for this year's test administration. The table indicates total enrollment and total number of students tested. It also provides a detailed breakdown of those students excluded from the exam. Note that this table includes all students according to grade level, even if they have not enrolled in at least their second year (defined as enrolled by BEDS day of the previous school year).

#### RESULTS AND EVALUATION

The academic achievement goal was that 75% of all scholars in at least their second year enrolled at Capital Preparatory Bronx School will perform at or above proficiency on the New York States ELA assessment.

While this subset of Capital Preparatory Bronx School scholars did not meet this measure (58% 7th-grade and 56% in 8th-grade), the proficiency rate is similar to the typical pre-COVID District 11 (Bronx) average and New York City average. This is also true for proficiency data representing all Capital Preparatory Bronx scholars.

#### ADDITIONAL EVIDENCE

#### **Goal 1: Comparative Measure**

Each year, the percent of all tested students who are enrolled in at least their second year and performing at proficiency on the state English language arts exam will be greater than that of all students in the same tested grades in the school district of comparison.

#### **METHOD**

A school compares tested students enrolled in at least their second year to all tested students in the public school district of comparison. Comparisons are between the results for each grade in which the school had tested students in at least their second year at the school and the total result for all students at the corresponding grades in the school district.<sup>2</sup>

#### RESULTS AND EVALUATION

At this moment, there is no access to current proficiency rates for the 2021-22 school year in either Bronx of New York state, the only relevant data to compare Capital Preparatory Bronx 2021-22 proficiency rates with would be the 2018-19 pre-COVID rates for District 11 (Bronx) and New York State.

The Capital Preparatory Bronx 2021-22 proficiency rates for both cohorts of scholars, all and second year, are greater or comparable to both District 11 (Bronx) and New York State pre-COVID testing data in 2018-19. The Bronx and New York state data for 2018-19 was as follows: 7th-grade proficiency for Bronx was 58% which was 10% greater than district 11 and NYS, typical pre-Covid. 8th-grade proficiency for the Bronx was 57% which was also about 10% greater than district 11 and NYS, also typical pre-Covid. Capital Preparatory Bronx 8th-grade proficiencies (for both cohorts) represents a greater score than District 11 and New York state proficiency pre-COVID rates. Bronx 7th-grade proficiency rates (for both cohorts) were greater than the District 11 pre-COVID rates and just under the New York state rates.

#### ADDITIONAL EVIDENCE

Both the second year English proficiency rates for 7th-grade and 8th-grades in the 2021-22 school year, 60% and 53% respectively, are comparable or represent growth in proficiency when comparing to the cohort from last year's assessments with proficiency rates of 58% for 6th-grade and 45% for 7th-grade in 2020-21. (Note: Approximately 50% of Capital Preparatory Bronx scholars took the state assessments in 2020-21).


#### **INTERNAL EXAM RESULTS**

During the 2021-2022 school year Capital Prep Bronx scholars were internally assessed three times on an ELA Benchmark (BA)which aligns to ELA Common Core Standards. The ELA Benchmark serves as an additional data point of how scholars are meeting grade level standards and which areas are in need of remediation, reflect on performance and create goals on how to achieve mastery before the end of the final quint (Quint 5). Each internal ELA benchmark assessment was administered in person and followed mandated accommodations for respective scholars.

Once data is collected, Capital Prep administration and Capital Prep Bronx leadership team reviewed test questions and data in post and pretest meetings to identify challenging questions and create strategies to implement for scholar mastery. According to Benchmark 2 data in relation to Benchmark 3 data, sixth grade's average was 56%. Of the 56%, 30% sixth graders were proficient in grade level ELA standards. Seventh grade averaged 61% in the beginning of year and of those scholars, 51% was proficient. Eighth graders averaged 56% with 24% scholars demonstrating proficiency.


By Quint 5, grades six through eight at Capital Prep Bronx demonstrated growth in ELA. Sixth grade performed at 53% proficiency in the final quint, seventh grade performed at 73 % proficiency and eighth grade performed at 68% proficiency.

The tables below demonstrate the overall average of each High-Level ELA Standards that was assessed on Capital Preparatory Benchmark 2 and 3.




Sixth grade scholars demonstrated higher averages in each of the standards in Benchmark 2 than they did on Benchmark 3.

Scholars in the seventh grade displayed a great amount of growth between BA 2 and BA 3, as displayed in the table below. Seventh graders grew the most in RL.7.1, where they 70% in BA 3 versus 59% on BA 2.



Eighth graders' performance indicates growth throughout the year, as BA 3 averages with greater than BA 2. Scholars' mastery of High Leverage Standards (RL.8.1 and RL.8.2) saw a sharp increase at the conclusion of the school year. Displayed below, scholars grew 12 points in RL.8.1, in addition to a 23 point increase in RL.8.2.



Reading Plus served as our supplemental reading program to support scholars increasing reading levels. In Quint 4, scholars were tasked to complete sixty minutes of individualized reading lessons each week to aid in their reading comprehension and fluency skills. Capital Prep Bronx scholars, grades six through eight, had an average of 83% completion of lessons between Quint 4 and 5, at an average of sixty minutes per week. For example, in grade six scholars averaged 85 lessons completion with a growth completion level of 2.3 increase in reading level. In grade seven, scholars averaged 81 lesson completion with a growth completion level of 2.7 increase in reading level, while eighth graders averaged 74 lessons with a growth completion rate of 2.3 increase in reading level.

During 2021-22, in addition to the New York State 3<sup>rd</sup>- 8<sup>th</sup> grade exams, Capital Prep primarily used the following assessment to measure student growth and achievement in ELA: Reading Plus, NWEA MAP and our internal ELA benchmarks.

Capital Prep Bronx took the NWEA MAP assessment three times during the year. Results in ELA showed that the median growth percentile for the 193 students who tested was 54 which indicates growth throughout the year (Measure 1). The 64 students (28-6th, 23-7th, 13-8th) who did not test at grade level proficiency at the beginning of the year on the ELA fall MAP assessment posted a median growth percentile of 74 at the end of the year (goal is 55) which indicates significant growth among the students who demonstrated a deficit at the beginning of the year (Measure 2).

# 2021-22 ACCOUNTABILITY PLAN PROGRESS REPORT

CPS Priority Standards are identified national standards that when focused upon provide accelerated access to grade-level proficiency, leverage for success on high-stakes assessments, and reach towards the acquisition of future grade-level skills. The emphasis on instruction, remediation, and enrichment of PS at CPS will communicate to scholars, families, and other stakeholders the importance of instructional rigor and depth of knowledge within the classroom.

Lessons designed with PS central to their objectives will improve the likelihood that scholars will become grade-level proficient in an accelerated manner and demonstrate skill proficiency on high-stakes assessments. Throughout the 2022-23 school year, a scholar's journey toward proficiency in skills identified by each ELA Priority Standard will be displayed on every class's interactive data wall. This transparency will encourage scholars who have not earned proficiency to strengthen foundational skills, practice grade-level skills, and finally, reassess to demonstrate newly earned mastery.

RTI days have been regularly programmed on Fridays during the 2022-23 SY to provide "in class" and "school day" remediation, reteach, or enrichment of grade-level ELA skills. Proficiency distribution as displayed on the class's interactive data wall will inform skills of focus, as well as purposeful groupings for instruction for each RTI day. Instruction will employ 'centers' of direct instruction, collaborative practice, and individual work on a programmed learning path focusing instruction on skills related to a PS. ELA RTI days and the use of data walls are described in the ELA RTI Padlet.

## **GOAL 2: MATHEMATICS**

#### Goal 2: Mathematics

Each year, 75 percent of all tested students enrolled in at least their second year will perform at or above proficiency on the New York State examination for grades 3-8.

#### BACKGROUND

Greatminds Eureka curriculum was employed for math instruction in grades 6-8 at Capital Preparatory Bronx School. This curriculum is aligned with the grade level skills outlined in both the CCSS and NYSTP, and is one-to-one with the EngageNY program. Each course scope and sequence mirrors that of the one provided in the curriculum during the school year. Playlists created in Edulastic specifically for use with the Great Minds curriculum were employed for both Module formative and summative assessments.

Scholars in grades 6 were provided with instruction in problem solving 2 days a week. Cadence, a program designed to infuse Cognitive Guided Instruction in the classroom, was employed as a parallel math curriculum to the Eureka program.

Fall mathematics MAP Growth scores suggested the need for a section of 8th grade Algebra. This course was offered to scholars with a RIT greater than 230. Houghton Mifflin Algebra Interactive curriculum was employed for math instruction for this section. The CPS scope and sequence was created to meet the needs of a truncated school year. In addition, scholars regularly participated in Saturday Regents preparation classes throughout the year where scholars sat for a Regents practice assessment, corrected and calculated their raw score, and reviewed solution strategies for each problem.

High Leverage Standards, math CCSS having the greatest effect on scholars acquiring math skill proficiency, have been identified by the math curriculum director and were assessed and re-assessed throughout the school year to determine level of scholar skill acquisition and identify the need for remediation and/or enrichment. Benchmark Assessments were issued three times during the school year, fall-winter-spring, to track scholar progress towards proficiency in these high leverage standards.

Zearn and IXL programs supplemented the Eureka curriculum, providing opportunities for scholars to practice foundational, on-grade and enrichment skills based on their individual needs.

Capital Preparatory Bronx scholars also participated in asynchronous learning at their proximal zone of development as identified by mathematics MAP Growth scores using the NWEA Accelerator platform. Scholars were to complete a minimum of sixty (60) minutes per week on their individual learning path as dictated by most recent MAP RIT scores.

Professional development for mathematics Illuminators during the school year includes weekly department meetings to discuss best practices, monthly data team meetings, weekly walkthrough observations coupled with individual coaching meetings, and 'upon request' individual meetings.

#### ELEMENTARY AND MIDDLE MATHEMATICS

#### Goal 2: Absolute Measure

Each year, 75 percent of all tested students enrolled in at least their second year will perform at or above proficiency on the New York State Mathematics examination for grades 3-8.

#### METHOD

The school administered the New York State Testing Program Mathematics assessment to students in 6th through 8th grades in spring 2022. Each student's raw score has been converted to a grade-specific scaled score and a performance level.

The table below summarizes participation information for this year's test administration. The table indicates total enrollment and total number of students tested. It also provides a detailed breakdown of those students excluded from the exam. Note that this table includes all students according to grade level, even if they have not enrolled in at least their second year (defined as enrolled by BEDS day of the previous school year).

#### RESULTS AND EVALUATION

The academic achievement goal was that 75% of all scholars in at least their second year enrolled at Capital Preparatory Bronx School will perform at or above proficiency on the New York States mathematics assessment.

While this subset of Capital Preparatory Bronx School scholars did not meet this measure (32% 7th-grade and 40% in 8th-grade), the proficiency rate is similar to the typical pre-COVID District 11 (Bronx) average and New York City average. This is also true for proficiency data representing all Capital Preparatory Bronx scholars. Additionally, Capital Preparatory Bronx School 8th-grade proficiency data does not include fifteen (15) scholars who sat for and passed the Algebra Regents assessment.

#### ADDITIONAL EVIDENCE

Both the second-year mathematics proficiency rates for 7th-grade and 8th-grade in the 2021-22 school year, 32% and 40% respectively, are comparable or represent growth in proficiency when comparing to the cohort from last year's assessments with proficiency rates of 37% for 6th-grade and 17% for 7th-grade in 2020-21. Also, please refer to the Capital Preparatory Mathematics Benchmark Assessments, which discusses students' progress on high-leverage standards (see "Internal Exams" below). (Note: Approximately 50% of Capital Preparatory Bronx scholars took the state assessments in 2020-21).

Additionally, fifteen (15) 8th-grade scholars passed the Algebra Regents. If they had taken the 8th-grade assessment, the proficiency rate would have dramatically increased to 66%, well above the typical Bronx, New York City, and New York state annual mean scores.

#### **Goal 2: Comparative Measure**

Each year, the percent of all tested students who are enrolled in at least their second year and performing at proficiency on the state mathematics exam will be greater than that of all students in the same tested grades in the school district of comparison.

#### **METHOD**

A school compares tested students enrolled in at least their second year to all tested students in the public school district of comparison. Comparisons are between the results for each grade in which the school had tested students in at least their second year at the school and the total result for all students at the corresponding grades in the school district.<sup>4</sup>

#### RESULTS AND EVALUATION

With no access to current proficiency rates for the 2021-22 school year in either Bronx of New York state, the only relevant data to compare Capital Preparatory Bronx 2021-22 proficiency rates with would be the 2018-19 pre-COVID rates for District 11 (Bronx) and New York State.

#### ADDITIONAL EVIDENCE

The Capital Preparatory Bronx 2021-22 proficiency rates for both cohorts of scholars, all and second year, are greater or comparable to both District 11 (Bronx) and New York State pre-COVID testing data in 2018-19. The Bronx and New York state data for 2018-19 was as follows: 7th-grade proficiency at 30% and 43% respectively, and 8th-grade proficiency being 27% and 33% respectively. Capital Preparatory Bronx 8th-grade proficiencies (for both cohorts) represents a greater score than both the Bronx and New York state proficiency pre-COVID rates. Bronx 7th-grade proficiency rates (for both cohorts) were greater than the Bronx pre-COVID rates and just under the New York state rates. Bronx pre-COVID, 2018-19, 6th-grade proficiency rates (31%) are similar to that of Capital Preparatory Bronx's 2021-22 testing data, 30%.

The fact that Capital Preparatory Bronx 2021-22 proficiency rates in mathematics are comparable to both the districts and state's pre-COVID rates is even more remarkable due to the negative effects of a global pandemic impacting New York City especially hard, remote learning, and a teacher shortage. The national trend is that these life events have devastated test scores, and by some accounts erasing "two decades of progress". We are excited that Capital Preparatory Bronx is matching pre-COVID proficiency rates for the District and State, as a school that opened during the full closures as a result of the pandemic and strive to continue on this trajectory.

#### **INTERNAL EXAM RESULTS**

During 2021-22, in addition to the New York State 3<sup>rd</sup>- 8<sup>th</sup> grade exams, the school(s) primarily used the following assessment to measure student growth and achievement in mathematics:

During 2021-22, the Capital Preparatory Bronx School primarily used the following exams to assess student growth and achievement in mathematics: Benchmark Assessments, Eureka summative and formative assessments as created in the Edulastic library, MAP and daily Zearn assessments. Mathematics Quint Benchmark assessments allowed for the tracking of scholar proficiency growth in High Leverage standards.

NWEA MAP assessments were administered three times during the school year: fall, winter and spring. Scholar RIT scores were used to create individual learning plans. Fall scores were used to program learning plans in the Accelerator program for scholars to work asynchronously on their learning plans starting at the end of September. Scholar placement was adjusted due to performance on each subsequent MAP assessment.

The assessment of High Leverage standards, standards identified by the mathematics curriculum director as those most likely to leverage grade level proficiency, was completed at the end of Quint 1, Quint 2, and Quint 5. Scholar standard proficiency data was triangulated with classwork data, such as Eureka assessments, to identify individual needs for remediation, enrichment and/or intervention.

Capital Prep Bronx took the NWEA MAP assessment three times during the year. Results in Math showed that the median growth percentile for the 198 students who tested was 62 (target was 50) which indicates growth throughout the year (Measure 1). The 86 students (28-6th, 39-7th, 19-8th) who did not test at grade level proficiency at the beginning of the year on the ELA fall MAP assessment posted a median growth percentile of 69 at the end of the year (goal is 55) which indicates significant growth among the students who demonstrated a deficit at the beginning of the year (Measure 2). Students with disabilities achieved a median growth percentile that was greater than the general education students at the school. The general education median growth percentile for the school was 62, whereas the 17 students with disabilities had a median growth percentile of 69 (Measure 3).

Capital Preparatory Mathematics Benchmark Assessments (BA) are employed to determine the proficiency of scholars in High Leverage Standards identified by the district to track scholar progress towards grade level proficiency. BAs were assessed three times during the 2021-22 school year, each assessment testing scholar proficiency on each of the High Leverage Standards taught up until that point.

The table below demonstrates the overall proficiency rates (score of 65% or greater) for Capital Preparatory Benchmark assessments, assessed in October, December, and June.


Scholar proficiency indicates growth throughout the school year as Quint 5 rates were either similar to or greater than those in Quint 1. This demonstrates growth as Quint 1 BAs assessed 3 or 4 High Leverage Standards with 15 or 20 questions, while Quint 5 BAs reassessed the same standards while assessing all other High Leverage Standards taught throughout the school year. Quint 5 BAs had a total of 14 standards with 52 questions for grade 6, 11 standards with 33 questions for grade 7, and 14 questions with 52 questions for grade 8.




Q5 High Leverage Standards - Bronx Grade 6








Q5 High Leverage Standards - Bronx Grade 7

#### ADDITIONAL CONTEXT AND EVIDENCE

The concerns regarding the proficiency rates described above are few, but very compelling. Research shows that at the end of the 2021-22 school year, scholars have only gained "between 15% and 35% of the learning they had lost" during remote learning made necessary by the global COVID pandemic. This learning loss should have had an adverse effect on Capital Preparatory Bronx scores, as it did nationally; meaning the Capital Preparatory Bronx proficiency rates that matched or bested the District 11 and New York State pre-COVID rates from 2018-19 would have been greater than those scores by an even greater amount.

The national teacher shortage also had an impact on implementing the Capital Preparatory Bronx mathematics scope and sequence in two different ways: (1) a capable mathematics teacher was not identified for 7th-grade mathematics until October, (2) a reliable long-term substitute capable to aptly teach mathematics was not available to provide coverage when the 6th-grade mathematics teacher was out for a month due to a medical issue. While teaching and learning occurred during these voids at Capital Preparatory Bronx, one can assume the quality and rigor of lessons would have been much improved with a qualified certified teacher in class during these times.

During the 2021-22 school year, Capital Preparatory Bronx scholars spent an average of 1,140 asynchronous minutes, during a thirty-one week period, working on their individual mathematics learning plan in the NWEA Accelerator program. The NWEA suggestion for this time was 930 minutes (30 minutes a week). The CPS expectations over the same time was 1,860 minutes. To improve middle school proficiency during the 2022-23 school year, Capital Preparatory Bronx illuminators will aggressively monitor weekly time on task to improve their scholar's time-on-task within the NWEA Accelerator program to meet the 1,860 minute expectation.

During the 2021-22 school year, fifteen (15) Capital Preparatory Bronx eighth graders were identified by a NWEA MAP Growth score of 230 or greater as being 'ready' for Algebra. These scholars were engaged in a rigorous, fast paced, Algebra program offered concurrently with their eight-grade math course that included an accelerated scope and sequence, after school skill academies, regular Regents raw score data tracking (from dress rehearsal assessments), and coaching on test-taking strategies. This resulted in 100% of the scholars meeting the 65% score for an Algebra Regents pass. The expectation for the 2022-23 school year is that as many Capital Preparatory Bronx scholars as possible will be identified to participate in a similar program to improve mathematics proficiency.

## **GOAL 3: SCIENCE**

#### Goal 3: Science

Each year, 75 percent of all tested students enrolled in at least their second year will perform at or above proficiency on the New York State science examination for grade 8.

#### **BACKGROUND**

Science instruction at Capital Prep Schools has been a combination of hands-on inquiry through labs and reading about science content in texts. Amplify Science is used in grades six, seven, and eight. The science curriculum is supported by staff and leaders participating in weekly science department meetings, collaborative planning, observation and feedback cycles, lesson modeling, professional development sessions, and sharing of various instructional strategies. The Amplify Science program provides assessments for each unit of study for scholars in sixth to eighth grade. Each grade level was provided a structure that includes a Do Now, videos and activities, vocabulary, notes, discussion, IXL, reading, writing, and projects. In addition, Edulastic Assessments were used to assess priority standards for all grade levels throughout the school year.

#### ELEMENTARY AND MIDDLE SCIENCE

#### Goal 3: Absolute Measure

Each year, 75 percent of all tested students enrolled in at least their second year will perform at or above proficiency on the New York State science examination.

#### METHOD

The school administered the New York State Testing Program science assessment to students in 8<sup>th</sup> grade in spring 2022. The school converted each student's raw score to a performance level and a grade-specific scaled score. The criterion for success on this measure requires students enrolled in at least their second year to score at proficiency.

#### RESULTS AND EVALUATION

Capital Prep Bronx School science goal is to have 75% of our 8th grade scholars be at or above proficiency on the NYS Science Assessment. During the 2021-2022 academic year, we had 71% of our grade 8 scholars score at or above proficiency on the NYS Science Examination. Additionally, the scholars who have attended Capital Prep Bronx for the last two years scored at 74% proficiency, narrowly missing the state's goal. These students received expert instruction with the same science Illuminator for both grades 7 and 8, providing systems, routines, and a classroom structure which all support high levels of learning and retention of learned information.

## SUMMARY OF THE ELEMENTARY/MIDDLE SCIENCE GOAL

Capital Prep Bronx School science goal is to have 75% of our 8th grade scholars be at or above proficiency on the NYS Science Assessment. Scholars who have attended Capital Prep Bronx for the last two years, received expert instruction with the same science Illuminator for both grades 7 and 8, providing systems, routines, and a classroom structure which all support high levels of learning and retention of learned information. While we use Amplify Science as our core curriculum program, we also supplement our science instruction with science IXL, hands-on inquiry labs, reading science content, infusing mathematics and writing as applicable, and creating STEM activities, projects, and events for scholars to extend and display their learning.

#### **ACTION PLAN**

To address lower than desired scholar proficiency rates in science the identification of Priority Standards (PS) for each science course has been made to promote a quicker path to a scholar's grade-level proficiency. This list of Science Priority Standards will inform the prioritization of science grade level skills for instruction and assessment during the 2022-23 school year.

CPS Priority Standards are identified national standards that when focused upon provide accelerated access to grade-level proficiency, leverage for success on high-stakes assessments, and reach towards the acquisition of future grade-level skills. The emphasis on instruction, remediation, and enrichment of PS at CPS will communicate to scholars, families, and other stakeholders the importance of instructional rigor and depth of knowledge within the classroom.

Lessons designed with PS central to their objectives will improve the likelihood that scholars will become grade-level proficient in an accelerated manner and demonstrate skill proficiency on high-stakes

assessments. The PS lists in this document will also inform a vertical alignment providing Illuminators with an understanding of skill commonalities amongst grades directly below and above their own.

The prioritization of standards at CPS does not mean the elimination of grade-level skills not listed. For each grade, a Grade Level Supporting Skill (GLSS) standard has been created to track a scholar's path toward proficiency in these secondary skills as well.

Tier 1 instruction in Science Priority Standards involves practice in skills related to the Least Restrictive Standard. A Least Restrictive Standard is the foundational standard *closest* in grade level to a Priority Standard that when studied would support access to proficiency within the PS skills.

All Science Priority Standards and mappings to LRS can be found here: Science Priority Standards

Throughout the 2022-23 school year, a scholar's journey toward proficiency in skills identified by each Science Priority Standard will be displayed on every class's interactive data wall. These data walls will be updated weekly to communicate the current standards-based skill level for every scholar across the PS studied in class. This transparency will encourage scholars who have not earned proficiency to strengthen foundational skills, practice grade-level skills, and finally, reassess to demonstrate newly earned mastery.

RTI days have been regularly programmed in the 2022-23 Science Scope and Sequence to provide "in class" and "school day" remediation, reteach, or enrichment of grade-level science skills. Proficiency distribution as displayed on the class's interactive data wall will inform skills of focus, as well as purposeful groupings for instruction for each RTI day. Instruction will employ 'centers' of direct instruction, collaborative practice, and individual work on a programmed learning path focusing instruction on skills related to a PS. Science RTI days and the use of data walls are described in this Padlet: Science RTI Padlet.

There was also a deep dive on curriculum and the principals led a classroom management session. TR also reviewed sports, advisory, SLC preparation and a focus on tightening up school routines and uniform compliance. TR also recognized a 7th grade scholar who advocated to modify the uniform to include a long sleeve sweater. This is what we want to see in our scholars.

#### 2. Capital Preparatory Bronx Charter School (dashboard)

IB reviewed the current enrollment of 242 scholars and noted that we are bringing in scholars to get to 249. IB also reviewed academics including October 15th benchmarks assessments and upcoming assessments. He reviewed learning loss mitigation strategies that appeared successful. TR reported on the current enrollment (443 scholars - goal of 500). The school is actively recruiting with two open houses a month. There are weekly recruiting meetings and ads on bus shelters.

The network professional development, on the day after Thanksgiving break, with the Special Education Collaborative for trauma was very informative. The school has also focused on reading

training, conducted SLCs last week, and held student government elections. Our advisory is doing community service projects. MAP testing will occur after break.

The Board discussed enrollment goals and the cause of the attrition and the process of back-filling throughout the year.

JJ discussed the network professional development, including the Reading Plus program. The fall ELA, math and science were completed. 7 college tours have occurred to date. JJ also discussed sports, including the Harbor v. Harlem classic game and the cheerleading squad. There were two successful senior summits to cover college applications and financial aid. 37 of our scholars applied for college courses at HOSTOS. 41 scholars are using About U - SAT prep with two sessions a week; we are looking to modify to three times a week going forward. We are focusing on data walls in the classrooms and on filling staffing vacancies. Student elections are this week, and we are doing Regents prep.

### 2. <u>Capital Preparatory Bronx Charter School (dashboard)</u>

IB noted that current enrollment is 243 scholars out of the 249 planned. The school is averaging 96% attendance. The second round of MAP is this month. The school is very pleased with the 97% completion rate for SLCs. The illuminators are focusing on gradebook quality and timeliness. They received data analysis training directly from NWEA. And, they are cultivating a culture of care.

The Board shouted out the Bronx, and IB applauded the leadership team, illuminators, and families.

IB spoke about family engagement by describing a town hall that occurred this past Saturday. There is a plan for bi-weekly town hall meetings and newsletters. We are making progress in MAP and SLP completion. The scholars are actively engaging with the community with homeless shelters and girls scout events. There are currently 201 applications. We have lots of time for applications and recruitment. Information sessions are planned at local schools.

JS noted that he had a great school visit. There was great teaching and learning with real engagement and substantive work. The school culture was very positive, and the care that the principal referenced was evident.




