school in a neighborhood with constantly shifting demographics and ntense demand for quality elementary
education, the school's admissions lottery was weighted to ensure that 40\% of ncoming Kindergartners are from the Ingersoll Houses, Walt Whitman Houses, and Farragut
Houses, public housing directly surrounding the school
building.

## The Anti-Bias Education Collective

In 2012, the Anti-Bias Education Collective (ABC) was formed to help our faculty create classroom communities that honor the different identities represented n our school and build a developmentally appropriate anti-bias curriculum that is centered upon justice. In doing this meaningful work, $t$ has been essential for staff members to address and reflect upon their own biases as well as the biases they feel towards others, both nside and outside the classroom. Made up of a team of staff members from within our school community, the ABC's nitial focus was to support the work of creating a social justice scope and sequence that is thoughtfully integrated into our existing social studies units. These efforts
were reinforced through the deeper integration of
critical literacy skills, the ntentional incorporation
of multiple perspectives, and by creating
opportunities for students to engage in social
action. The ABC continues to meet regularly to
design and facilitate staff trainings on topics
related to equity and, each summer, it puts
together a reading list that allows all members of
the community to reflect upon ssues connected to
identity, racism, power, privilege, and nclusion.

Despite the cancellation of the statewide tests, we did not change our curriculum or scope and sequence in ELA or Math. In March June staff continued to deliver high quality instruction through pre-recorded videos, and assignments that addressed the standards and taught skills needed to perform on the state wide exams.

While we do not believe there sa perfect replacement for the tate Exams, and therefore ha e not and will not draw a correlation between other formative and summative assessments, we administered our end of year assessments for the most part as scheduled.

Lastly, our continuity of learning plan for the 2020-2021 school year focused on what was learned in the spring. We made adjustments that are aimed at increasing engagement and understanding. Our model is that instruction more closely resembles a school day and instruction s more synchronous than asynchronous. Instructional staff also deliver small group and individual instruction to target learning needs.

At CRCS we hire and train teachers who understand the connection between student's academic progress and social emotional well being. We regularly assess our students $n$ reading, writing, and math to

ensure that adequate progress is being made using a combination of formal and nformal assessments. After rounds of data collection team meetings are held where Learning Specialists and faculty come together to initiate intervention plans for students not meeting academic benchmarks or not making adequate progress. In addition each Co-Director meets with co-teaching teams every other week to d scuss student progress and one of these meetings each month a social worker joins to focus on social emotional development and well being.
We have open communication between families and teachers to communicate both formally and informally about children's academic progress and social emotional development. This is done through 3 formal reporting cycles a year and through classroom pick up and drop off as well as by ensuring that families have access to teachers via text, email, phone, in person contact (whatever means works best for that family).
In addition we work to build strong relationships with families through opening classrooms every morning for Family Read, inviting families into classrooms to see children's work through classroom culminations 3-4 times a year, and have a robust set of Family Programming; including programs that are adult only, and for families and children together. We use the same strategies described above to retain our students with disabilities as we know that meeting students academic and social emotional needs as well as building deep relationships with families is essential for all students.
We meet with prospective and accepted families in order to discuss student specific needs

Students with Disabilities
and supports.
We utilize a full time co-teaching model and have trained all staff in Universal Design for Learning to increase access to the general education curriculum and state standards. Additionally, a working group of school staff, called the Inclusive Practices Group, meets to examine the level of nclusivity of our program and design opportunities for staff development and program improvement. We worked on revised website language to include additional information regarding special education services and our inclusive education approach. This includes a description of services, our approach to teaching and learning, and structures and strategies to improve access for all of our students (UDL and co-teaching).

Continue with the strategies for the 2019-2020 school year and focus on bu ld ng a strong and inclusive program n each of our classrooms, allowing all learners to thrive.
