Proposed Revision(s):To start in the 2019-2020 school year, Charter School of

Educational Excellence is requesting revisions in their charter in order to transition into a regional school; to expand to serve students in grades K-12 from the current grades K-8; and to expand their enrollment plan

from 729 students to 1129 students.

It is proposed that 50% of all new and incoming students will reside in the Yonkers City School District with the remaining students coming from other school

districts in the region.
