

Economically Disadvantaged	Democracy Prep Charter School is open to any child who is eligible under the laws of the State of New York for admission to a public school, and the school ensures compliance with all applicable anti discrimination laws governing public schools, including Title VI of the Civil Rights Act and § 2854(2) of the New York Education Law, governing admission to a charter school. HPCS used various outreach efforts in 2021-22 to attract and retain students who are at risk of academic failure and will continue to adopt and implement new measures designed to retain such students in 2022-23 and beyond. Specifically, we contact guidance counselors in elementary, middle and high schools in Community School District 5 in order to identify high needs students who could naturally feed into Democracy Prep Charter School. We also depend on analytical tools to inform recruitment decisions. With support from network resources, Democracy Prep is informed on the neighborhood demographic trends, application to acceptance conversion rates, and previous year's retention rates. This equips canvassers with more targeted walk lists and recruitment strategies.	Democracy Prep Charter School will begin to advertise open registration in October each year, and conducts Open Houses beginning in January. Interested families will meet with staff and review the expectations of the school.
