Description Regents Item:	Evergreen Charter School proposes to expand its student body from 300 students to 375 students for the 2016-2017 school year. The expansion includes two separate components: an expansion to include a sixth grade, serving 50 students and the inclusion of an additional kindergartner class of 25 students. The school has provided evidence to support the fact that present facility will be able to accommodate proposed enrollment.

The application for this school is being reviewed for possible action at an upcoming Board of Regents meeting.

Please note that pursuant to Education Law section 2857(1) and 8 NYCRR 119.4 (available at <http://www.p12.nysed.gov/psc/law.html>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing revision. This hearing, which is required to be held within the community that is potentially impacted by the charter school, must be held within 30 days of your receipt of this letter.
