- A revision requested by this charter school to change the name of the school from Syracuse Academy of Science and Citizenship Charter School to Citizenship and Science Academy of Syracuse Charter School. This revision is proposed to commence in the 2022-2023 school year. A determination regarding this revision has not yet been made and is currently under review by the New York State Education Department.
- A proposed revision to amend the charter school's organizational chart to reflect significant changes. This revision is proposed to commence upon approval in the 2021-2022 school year. A determination regarding this revision has not yet been made and is currently under review by the New York State Education Department.
- A revision requested by this charter school to increase the charter school's current grade span to add Grades 7 through Grade 11 to the school's currently approved Kindergarten through Grade 6 configuration to commence in the 2022-2023 school year and be fully implemented by the 2026-2027 school year. A determination regarding this revision has not yet been made and is currently under review by the New York State Education Department.
- A revision requested by this charter school to increase the charter school's authorized enrollment from the currently approved 525 students to 900 students to

commence in the 2022-2023 school year and be fully implemented by year 5 of the renewal charter term which will be the 2026-2027 school year. A determination regarding this revision has not yet been made and is currently under review by the New York State Education Department.

The application of this school is being reviewed for possible action at an upcoming Board of Regents meeting. You are receiving this notice since the school is located in your school district and/or your school is located in the same geographic region as the charter school seeking this proposed action. If you are not the school's district of location, as indicated above, nothing further is required. However, if you seek to provide public comment regarding this proposed revision, additional information on how to do so is provided below.

Please note that pursuant to Education Law §2857(1) and 8 NYCRR §119.4 (available at <u>http://www.p12.nysed.gov/psc/aboutcharterschools/lawsandregs/law.html</u>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing application. The hearing, which is required to be held within the community that is potentially impacted by the charter school, must be held within 30 calendar days of receipt of this letter.

The charter school's district of location is required to provide the following required documentation to the Charter School Office:

- 1. A copy of the public hearing notice, at the **time of dissemination**.
- 2. Written confirmation that this hearing was held, no later than the **next business day** following the hearing.
- 3. Copies of any and all written records or comments generated from this hearing within **15 business days** after the hearing.
- 4. **A summary** (shown below) outlining the date and time of the hearing, the number of people who attended, the number of speakers, the number of people in favor, and the number of people opposed, and any comments received **in the following format**:

In addition, as stated above, the Board of Regents welcomes all public comments on the proposed application, including those related to the programmatic and fiscal impact of the proposed application on other public and nonpublic schools in the area. Comments can be submitted during the public hearing or can be submitted to <u>charterschools@nysed.gov</u> with a subject line of "School District Response to [Name of Charter School] Application."
