This notice is to inform you that on August 1, 2016, the New York State Board of Regents received a proposed renewal application from the KIPP NYC Washington Heights Academy Charter School. The renewal application for this school is being reviewed for possible action at an upcoming Board of Regents meeting.

Please note that pursuant to Education Law §2857(1) and 8 NYCRR §119.4 (available at <u>http://www.p12.nysed.gov/psc/law.html</u>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing application. These hearings, which are required to be held within the community that is potentially impacted by the charter school, must be held within 30 days of your receipt of this letter.

## Please provide the following required documentation:

- A copy of the public hearing notice must be provided to the Charter School Office at the time of dissemination.
- Written confirmation that this hearing was held must be sent to the Charter School Office no later than the next business day following the hearing.
- Copies of any and all written records or comments generated from this hearing must be sent to the Charter School Office within 15 business days after the hearing.
