- The boards of New Visions Charter High School for Advanced Math and Science II, New Visions Charter High School for the Humanities II, and New Visions Charter Schools, charter school education corporations authorized by the New York State Board of Regents, seek to merge with the boards of New Visions Charter High School for the Humanities and New Visions Charter High School for Advanced Math and Science, charter school education corporations authorized by the State University of New York Board of Trustees, such that when the merger is approved, New Visions Charter Schools would be the surviving education corporation under the amended name, "United Charter High Schools," and authorized by the New York State Board of Regents beginning in the 2024-2025 school year. A determination regarding this revision has not yet been made and is currently under review by the New York State Education Department.
- A revision requested by New Visions Charter High School for Advanced Math and Science II to discontinue a contract between the charter school and New Visions for Public Schools, an entity that provides

comprehensive management services, beginning in the 2024-2025 school year. A determination regarding this revision has not yet been made and is currently under review by the New York State Education Department.

 A revision requested by New Visions Charter High School for Advanced Math and Science II to change the name of the school from New Visions Charter High School for Advanced Math and Science II to "United Charter High School for Advanced Math and Science II," beginning in the 2024-2025 school year. A determination regarding this revision has not yet been made and is currently under review by the New York State Education Department.

The application of this school is being reviewed for possible action at an upcoming Board of Regents meeting. You are receiving this notice since the school is located in your school district and/or your school is located in the same geographic region as the charter school seeking this proposed action. If you are not the school's district of location, as indicated above, nothing further is required. However, if you seek to provide public comment regarding this proposed revision, additional information on how to do so is provided below.

Please note that pursuant to Education Law §2857(1) and 8 NYCRR §119.4 (available at <u>http://www.p12.nysed.gov/psc/aboutcharterschools/lawsandregs/law.html</u>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing application. The hearing, which is required to be held within the community that is potentially impacted by the charter school, must be held within 30 calendar days of receipt of this letter.

The charter school's district of location is required to provide the following required documentation to the Charter School Office:

- 1. A copy of the public hearing notice, at the **time of dissemination**.
- 2. Written confirmation that this hearing was held, no later than the **next business day** following the hearing.
- 3. Copies of any and all written records or comments generated from this hearing within **15 business days** after the hearing.
- 4. **A summary** (shown below) outlining the date and time of the hearing, the number of people who attended, the number of speakers, the number of people in favor, and the number of people opposed, and any comments received **in the following format**:

"The required public hearing was held by the ___[full name of School District/New York City Department of Education] on ___[Date]___, 20[YY]. ___[Number]___ people attended, and ____[Number]___ spoke. __[Number]___ were in favor of the [renewal/revision/merger] and ____[Number]___ were opposed."

All documentation listed above must be submitted to <u>charterschools@nysed.gov</u>. The subject line of the e-mail

should read "[Name of Charter School] Public Hearing."

In addition, as stated above, the Board of Regents welcomes all public comments on the proposed application, including those related to the programmatic and fiscal impact of the proposed application on other public and nonpublic schools in the area. Comments can be submitted during the public hearing or can be submitted to <u>charterschools@nysed.gov</u> with a subject line of "School District Response to [Name of Charter School] Application."
