This notice is to inform you that on August 29, 2022, the New York State Board of Regents received one application to establish a charter school within the City of Olean. This application is under review for possible action at the December 12-13, 2022 Board of Regents meeting. Full application materials may be viewed on our website.

Please note that pursuant to <u>Education Law section 2857(1)</u> and <u>8 NYCRR 119.4</u>, the school district of location is required to hold a public hearing to solicit comments from the community relating to the foregoing applications. This hearing, which is required to be held within the community that is potentially impacted by the charter school, must be held **within 30 days of your receipt of this letter** (*October 12, 2022*).

Please provide the following required documentation:

- 1. A copy of the public hearing notice at the time of dissemination.
- 2. Written confirmation that the hearing was held no later than the next business day following the hearing.
- 3. Copies of all written records or comments generated from this hearing should be sent within 15 business days after the hearing (*November 2, 2022*).

All documentation listed above should be submitted electronically to <u>CharterSchools@nysed.gov</u> (the subject line of the email should include the NAME OF PROPOSED CHARTER SCHOOL *Public Hearing*).

In addition, Olean City School District has the right to comment directly to the Board of Regents on the programmatic and fiscal impact of the proposed charter school on traditional public and non-public schools in your district. Comments should be submitted no later than **October 12, 2022** to <u>CharterSchools@nysed.gov</u> (the subject line of the email should read: *Olean City School District response to* NAME OF PROPOSED CHARTER SCHOOL *application*).
