3. Copies of all written records or comments generated from this hearing must be sent within 15 business days after the hearing.

In addition, Buffalo Public Schools has the right to comment directly to the Board of Regents on the programmatic and fiscal impact of the proposed charter school(s) on traditional public and non-public schools in your district. Comments should be submitted no later than November 1, 2017 to <a href="mailto:charterschools@nysed.gov">charterschools@nysed.gov</a> (the subject line of the email should read: Buffalo Public Schools' response to NAME OF PROPOSED CHARTER SCHOOL application).
