Description Regents Item:	The Young Women's Collegiate Preparatory Charter School of Rochester requests approval to relocate from the Rochester City School District to the Greece Central School District beginning with the 2016-2017 school year. Young Women's Collegiate Preparatory Charter School of Rochester currently serves 300 students in grades 7-10 and has been authorized to serve 375 students in grades 7-11 in the 2016-2017 school year.

The application for this school is being reviewed for possible action at an upcoming Board of Regents meeting.

Please note that pursuant to Education Law section 2857(1) and 8 NYCRR 119.4 (available at <http://www.p12.nysed.gov/psc/law.html>), the school district of location is required to hold a 'public hearing' to solicit comments from the community in connection with the foregoing revision. This hearing, which is required to be held within the community that is potentially impacted by the charter school, must be held within 30 days of your receipt of this letter.
