

# <u>NEED-TO-KNOW</u>



#### What is the purpose of the New York State P-12 Learning Standards for the Arts?

The Standards support NYSED's objective to provide all New York State P-12 students with access to learning in Dance, Music, Theater, Visual and Media Arts; delivered by certified teachers employing instruction reflective of research and best practices; using sequential, standards-based Arts curricula; along with quality resources and support from community stakeholders.

The Standards leverage four Artistic Processes—Creating, Performing, Responding, and Connecting—to support students' artistic literacy.

## What does it mean to be artistically literate?

### The Arts provide unparalleled access to:

- Knowledge and culture.
- Multiple modes of learning and expression.

• Creating, Performing, Responding, and Connecting experiences.

#### The Arts also:

- Build a more integrated understanding of self and community.
- Directly engage students in independent and collaborative goal-seeking choices.

• Inspire, engage, challenge, and focus the mind.

• Build collaboration and problem-solving skills.

• Lay a foundation for creative capacity, and the development of innovators and creators.

# How do the Standards relate to 21st Century Skills?

21st Century Skills include creativity, critical thinking, collaboration, and communication.

Participation in the Arts facilitates creative problem solving and innovative thinking, which encourages global learning and civic engagement. Arts students focus on ideas, interactions and collaboration. They participate as decision-makers in the production, presentation, or performance of their artistic work.

Counselors, teachers, and students should work together in partnership with professional artists to expand curriculum-based Arts experiences and create opportunities for work experience.



### ARTS STANDARDS a summary of the nys standards for the arts

Four *Artistic Processes* (Creating, Performing/Presenting/Producing, Responding, and Connecting) and eleven *Anchor Standards* are shared by all arts disciplines. These representt the essential undersandings and skills students gain

as they engage in the arts.

Enduring Understandings and Essential Questions provide discipline specific guidance toward acievement of the Anchor Standards. Grade level specific Performance Indicators identify key outcomes by grade level within the specific Arts disciplines.
