Learning Technology Grant Program

Learning Technology Grant program participants are expected to develop, implement, and share programs, activities, and materials designed to:

- facilitate the delivery of quality instruction,
- increase equitable access to high-quality learning experiences, and
- promote culturally- and linguistically-responsive learning environments for all students through using educational technology.



Learning Technology Grant Program
