The goals set forth in the TIP plan shall be modeled after the principles of SMART goals (specific, measurable, attainable, realistic and timely) and shall address one (or more) of the specific domains in the Rubric.

The Plan shall include, but is not be limited to, an identification of the elements and or indicators in need of improvement, a timeline for achieving improvement, suggestions for improvement, support to be provided, and measurable outcomes to be evaluated.
