<input checked="" type="checkbox"/> Group 1	<p>In 2021-22 the District applied for a variance and designed a professional learning project to foster and promote the staff member's individual professional growth in closing learning gaps or social-emotional learning practices. The project was designed for one year. The teacher or team of teachers developed a focus to help them develop lessons and strategies to close learning gaps or address social-emotional learning in their instruction. They then put into practice the new learning during the 2021-22 school year.</p> <p>The District found significant value in developing projects as previously described. The projects developed by teachers were essential in recognizing the importance of attending to academic and social-emotional deficits created due to the pandemic; they also provided an opportunity for teachers to problem-solve and work collaboratively in attending to the heightened needs of our student population.</p> <p>By broadening the scope of these projects through the innovative variance, teachers will be able to further expand the focus of the project to students' academic, social-emotional, and behavioral needs. Furthermore, the project will provide an opportunity for the evaluator to examine and evaluate elements from within the Marzano rubric beyond what is traditionally observed in a classroom visitation, such as planning, preparation, collegiality, collaboration, professionalism, and reflection on teaching practice.</p>

The observation will be weighted at 90%, and the professional learning project will be weighed at 10% using the Marzano rubric approved in the APPR plan. The observation scoring process will be the same as the district's approved plan. The evaluator will approve the professional learning project. Next, the teacher or team will present to the evaluator the project plan, goals and resources, action steps, and the need for professional learning to enhance the teachers' skills.</p> <p>At the conclusion of the project, each teacher will meet with the evaluator or designee for a conference to present a summary of the professional learning project. The project will include, but is not limited to, observations, artifacts such as assessment data, delineation of new strategies, listings of both hardware and software that enhanced instruction, student feedback, reflective journals, lesson plans, and attendance data.</p>

	<p>The conference will be scheduled any time after April 1st of that school year.</p> <p>The professional learning project will be evaluated using the Marzano Teacher Practice Rubric, and evaluators will score the project using any of the 60 design elements within the four domains of the Marzano Teacher Practice Rubric. The project elements will be scored using a four-point rubric (4- highly effective, 3- effective, 2- developing, 1- ineffective.) The outcomes will provide a comprehensive measure of the teacher's knowledge and understanding of the project's impact on student learning. The elements scored will be equally weighted and will produce an average score.</p> <p>For each year we implement the innovative variance, the District will apply for the independent evaluator hardship waiver. For years in which waiver is granted, both the portfolio project and observation will be conducted by the lead evaluator. For the years in which the waiver is not granted, the independent evaluator will conduct the portfolio project, and the lead evaluator will conduct the observation.</p>

Evaluators spend multiple days viewing video examples, artifacts, and written feedback to become more proficient in the teacher evaluation process. Data from the previous school year allows for the analysis of interrater reliability and the evaluation process's effectiveness.</p> <p>The quality of the project will be measured based on the teacher or team of teachers' ability to demonstrate knowledge gained as well as the impact on student learning as a result of the project implementation. The evaluator will use the presentation of project instructional artifacts as evidence of teachers' knowledge or understanding of the impact on student learning in the scoring of the design elements within the Marzano Teacher Evaluation Model.</p> <p>Continuous assessment is a necessary component of professional growth. The goal of the annual review of performance is to provide an opportunity for tenured faculty members to reflect on the school year, acknowledge success and challenges, and identify goals and future activities that will lead to professional growth.</p>

<input checked="" type="checkbox"/> Group 1	<p>Annually, the district examines and interprets data to identify the top professional learning needs of 300 teachers participating in an end-of-year survey. Additionally, evaluators will conduct a needs assessment to determine the necessary professional learning opportunities for teachers. The district will use this information collectively to provide targeted professional learning opportunities during opening days for teachers based on this data. The feedback from the professional learning days informs the district of ongoing professional growth and what would be best focused on in future professional learning projects.</p> <p>Furthermore, as research shows, the most effective model to provide professional learning is one where teachers learn in a cohort group, have the opportunity to try out what they are learning, and provide feedback to one another, hence the district's decision to allow teams to work in groups on this project. These learning and teaching experiences will be explicitly reflected in their professional learning project.</p> <p>We continue to enhance our district's professional learning plan to grow professional opportunities for Clarence teachers. Our differentiated model for professional learning continues to be successful in meeting the needs of our adult learners. In our model, expert teachers share best practices with their colleagues, problem-solve, and create support networks. The professional learning project allows teachers to hone their skills and improve their practice through a systematic, organized approach to professional learning to support student growth and achievement.</p> <p>Through implementing the innovative variance and the professional learning project, the District can provide more targeted, specific professional growth opportunities to teachers based on the essential knowledge and skills each teacher identifies as a need or an area for improvement. Administrators will use the information gleaned from both a needs assessment and professional learning projects to develop professional learning opportunities that will help support teachers in the improvement of their practice which ultimately has a positive impact on student performance and achievement.</p>
