Teacher Improvement Plan

- A. Upon receiving a rating of "developing" or "ineffective", a teacher shall be provided with a Teacher Improvement Plan ("TIP"). The TIP shall be provided as soon as practicable, but in no case later than ten (10) school days after the opening of classes for the school year.
- B. The parties understand and agree that the sole and exclusive purpose of a TIP is the improvement of teaching practice and that the issuance of a TIP is not a disciplinary action. The TIP shall be created by the lead evaluator with input from the teacher and union representative, if one is assigned. The Federation President shall be informed of the District's intent to provide a TIP to a teacher within ten (10) days of the teacher's annual composite "developing" or "ineffective" rating. Whenever a teacher is placed on a TIP and the teacher agrees, the Federation President shall be provided with a copy of the TIP. A teacher who is on a TIP may not have their assignment (building, grade level) changed, or, on the secondary level, have new courses added, without their consent.
- C. A TIP shall clearly specify: (i) the area(s) in need of improvement; (ii) the performance goals, expectations, benchmarks, standards and timeliness the teacher must meet in order to achieve an effective rating; (iii) how improvement will be measured and monitored, and provide for periodic reviews of progress and goal achievement; (iv) the anticipated frequency and duration of meetings of the teacher, administrator, and peer assistant (if one is assigned); and (v) the appropriate differentiated professional development opportunities, materials, resources and supports the District will make available to assist the teacher, including, where appropriate, the assignment of a peer assistant.
- D. The length of a TIP for a probationary teacher shall be two (2) to five (5) months in duration, as determined by the District. The length of a TIP shall be not less than five (5) months in duration for a tenured faculty member, as determined by the District. Notwithstanding the foregoing, if the District, GTF and the member mutually agree, a TIP for a tenured member may be less than five (5) months.
- E. In the event that the administrator recommends coursework, any tuition costs or registration fees shall be borne by the District in their entirety. A teacher on a TIP shall not be required to perform work beyond the school day, week or year to comply with the requirements of a TIP. At the teacher's option, the teacher may elect to pay tuition for classes that are ordered as part of the TIP and receive salary credit for the classes to the extent such credit is available under the collective bargaining agreement. No disciplinary action predicated upon ineffective performance shall be taken by the District against a teacher until a TIP has been fully implemented. However, nothing herein shall prevent the District from introducing into evidence an evaluation or a TIP in a subsequent disciplinary action.
- F. A TIP shall be in narrative form, or other mutually agreed upon format.
- G. Note Subpart 30-3 of the Rules of the Board of Regents provides that "nothing [in that subpart] shall be construed to affect the unfettered statutory right of a district to terminate a probationary (non-tenured) teacher or principal for any statutorily and constitutionally permissible reasons."

Greenburgh Central School District Professional Improvement Plan

The **Professional Improvement Plan (PIP)** is a structured plan designed to support principals at the end of the school year. It addresses specific concerns and outlines a plan of action to address these concerns within a specific timeframe.

A PIP must be initiated whenever a principal receives a rating of *developing* or *ineffective* in an annual evaluation. A PIP shall be designed by the principal and the superintendent and/or his/her designee in collaboration with the president of the GAO or his/her designee over the course of the summer to be in place as soon as practicable, but in no case later than ten (10) school days after the opening of classes for the school year. An initial conference shall be held at the beginning of the school year where the PIP is discussed, signed and dated at the beginning of its implementation.

After the first quarter, the Superintendent and/or his/her designee will assess the effectiveness of the intervention and the level of improvement. Based on that assessment, the PIP may be adjusted appropriately and quarterly meetings among all parties will continue. If the PIP goals are met, the PIP will terminate. The culmination of the PIP will be communicated in writing to the principal and both parties will sign off on the PIP (at the end of the school year).

If the principal is rated as *developing* or *ineffective* for any school year in which a PIP was in effect, a new plan will be developed by the principal and the superintendent in collaboration with the Greenburgh CSD Administrative Organization according to these guidelines for the subsequent year.

Note - Subpart 30-3 of the Rules of the Board of Regents provides that "nothing [in that subpart] shall be construed to affect the unfettered statutory right of a district to terminate a probationary (non-tenured) teacher or principal for any statutorily and constitutionally permissible reasons."
