#### WHAT MAY BE CHALLENGING IN AN APPEAL

Appeal procedures will limit the scope of appeals under Education Law S3012-d to the following subjects:

- (1) the substance of the annual professional performance review; which shall include
- i. the instance of a teacher rated Ineffective on the student performance category but rated Highly Effective on the observation/ school visit category based on an anomaly, as determined locally.
- (2) the school district's or board of cooperative educational services' adherence to the standards and methodologies required for such reviews, pursuant to Education Law S3012-d and Subpart 30-3 of Commissioner's regulations;
- (3) the adherence to the Commissioner's regulations, as applicable to such reviews and compliance with any applicable locally negotiated procedures, as required under Education Law S3012-d; and
- (4) the school district's or board of cooperative educational services' issuance and/or implementation of the terms of the teacher improvement plan under Education Law S3012-d.

#### PROHIBITION AGAINST MORE THAN ONE APPEAL

A teacher may not file multiple appeals regarding the same performance review or teacher improvement plan. All grounds for appeal must be raised with specificity within one appeal. Any grounds not raised at the time the appeal is filed shall be deemed waived.

#### BURDEN OF PROOF

In an appeal, the teacher has the burden of demonstrating a clear legal right to the relief requested and the burden of establishing the facts upon which petitioner seeks relief.

#### TIMEFRAME FOR FILING APPEAL

All appeals of APPR ratings must be submitted in writing no later than 15 calendar days of the date when the teacher receives his or her APPR. If a teacher is challenging the issuance or implementation of a teacher improvement plan, appeals must be filed with 15 days of issuance or of identification of problem(s). The failure to file an appeal within these timeframes shall be deemed a waiver of the right to appeal and the appeal shall be deemed abandoned.

When filing an appeal, the teacher must submit a detailed written description of the specific areas of disagreement over his or her performance review, or the issuance and/or implementation of the terms of his or her improvement plan and any additional documents or materials relevant to the appeal. The performance review and/or improvement plan being challenged must also be submitted with the appeal. Any information not submitted at the time the appeal is filed shall not be considered.

#### TIMEFRAME FOR DISTRICT/BOCES RESPONSE

Within 15 calendar days of receipt of an appeal, the school district/BOCES staff member(s) who issued the performance review or were or are responsible for either the issuance and/or implementation of the terms of the teacher's improvement plan must submit a detailed written response to the appeal. The response must include any and all additional documents or written materials specific to the point(s) of disagreement that support the school district's or BOCES' response and are relevant to the resolution of the appeal. Any such information that is not submitted at the time the response is filed shall not be considered in the deliberations related to the resolution of the appeal. The teacher initiating the appeal shall receive a copy of the response filed by the school district/BOCES, and any and all additional information submitted with the response, at the same time the school district/BOCES files its response.

#### DECISION-MAKER ON APPEAL

A decision shall be rendered by the superintendent of schools or the superintendent's designee except that an appeal may not be decided by the same individual who was responsible for making the final rating decision. In such case, the board of education shall appoint another person to decide the appeal.

### DECISION

A written decision on the merits of the appeal shall be rendered no later than 30 calendar days from the date upon which the teacher filed his or her appeal. The appeal shall be based on a written record, comprised of the teacher's appeal papers and any documentary evidence accompanying the appeal, as well as the school district/BOCES' response to the appeal and additional documentary evidence submitted with such papers. Such decision shall be final.

The decision shall set forth the reasons and factual basis for each determination on each of the specific issues raised in the teacher's appeal. If the appeal is sustained, the reviewer may set aside a rating if it has been affected by substantial error or defect, modify a rating if it is affected by substantial error or defect or order a new evaluation if procedures have been violated. A copy of the decision shall be provided to the teacher and the evaluator or the person responsible for either issuing or implementing the terms of an improvement plan, if that person is different.

The Principal Improvement Plan (PIP) is designed to provide support through communication, discussion and collaboration in the area (s) of significant concern. The primary responsibility for correction of the deficiencies remains with the principal. The administrator and principal will agree on a mutual time-line to improve any noted deficiencies. A PIP must be instituted by October 1<sup>st</sup> of the school year next following the school year in which the principals performance was rated Ineffective or Developing Overall, as soon as practical thereafter when an administrator believes additional supports are needed for a principal in question.

#### The Purpose of a PIP is to:

- improve principal performance;
- provide support;
- provide due process for possible disciplinary action;
- provide information to determine tenure

A Principal Improvement Plan (PIP) must be initiated whenever the principal receives a rating of *developing or ineffective* in a year-end evaluation. Both the principal and Superintendent, or designee will meet for an evaluation conference at the end of the school year where the developing or ineffective evaluation is discussed.

A PIP is designed by the Superintendent or designee in collaboration with the principal. The PIP must be in place no later than October  $\mathbf{1}^{st}$  of the following year. An initial conference is held at the beginning of the school year where the PIP is discussed, signed and dated at the beginning of its implementation.


The principal must be offered the opportunity for a peer mentor. The principal will select the mentor, with the approval of the Superintendent. If the principal cannot decide on a mentor, the Superintendent or designee will select a mentor. All dealings between the mentor and the principal will be confidential. The mentor and the principal will collaborate during the first quarter. During that time, the principal will be observed at least once per quarter by members of the administrative team designated by the Superintendent who will concentrate on observing and evaluating goals identified in the PIP. A member of the administrative team will meet with the principal in a timely manner (within 5 school days) to discuss the observations. Written observation summaries will be provided (within 7 school days) and must be signed by both parties and the Superintendent. The principal will have the right to respond to observation summaries and responses will be attached.

After each quarter of Principal/mentor collaboration, the Superintendent or his/her designee will assess in writing the effectiveness of the intervention and the level of improvement. Based on that assessment, the PIP may be adjusted appropriately and quarterly meetings among all parties will continue. At the end of the year, if the PIP goals are met, it will terminate. The culmination of the PIP will be communicated in writing to the principal and signed by both parties.

Also, at the end of the school year in which a PIP was in place, the administration shall provide the principal with a summative evaluation for the school year which includes an APPR rating of highly effective, effective,

developing or ineffective. The principal, upon receiving this summary year end APPR rating, shall have the appeal rights accorded under the APPR plan.


If the principal is rated as developing or ineffective again, the principal and Superintendent or designee will develop a new plan for the next school year.





- Assure that, beginning in the 2019-2020 school year, any educator who receives a Developing or Ineffective rating on
  their original overall rating pursuant to this APPR plan will receive a Teacher Improvement Plan or Principal
  Improvement Plan, in accordance with all applicable statutes and regulations, by October 1 in the school year following
  the school year for which such teacher's or principal's performance is being measured or as soon as practicable
  thereafter;
- Assure that such improvement plan shall be developed by the superintendent or his/her designee in the exercise of
  their pedagogical judgment, and shall be subject to collective bargaining to the extent required under Article 14 of the
  Civil Service Law;
- Assure that all evaluators and lead evaluators, including independent evaluators and peer evaluators, as applicable, will be properly trained and that lead evaluators will be certified and recertified as necessary in accordance with all applicable statutes and regulations;
- Assure that the district or BOCES has collectively bargained appeal procedures that are consistent with the statute and regulations and that they provide for the timely and expeditious resolution of an appeal to the district/BOCES;
- Assure that, for teachers, all observable NYS Teaching Standards/Domains of the selected practice rubric are assessed
  at least once a year across the total number of annual observations and, for principals, all observable ISLLC 2008
  Leadership Standards/Domains of the selected practice rubric are assessed at least once a year across the total

- Assure that it is possible for a teacher or principal to obtain each point in the scoring ranges, including 0, for each
  subcomponent and that the district and BOCES shall ensure that the process by which weights and scoring ranges are
  assigned to subcomponents and categories is transparent and available to those being rated before the beginning of
